DRUG SITUATION REPORT/SIGNIFICANT EVENTS REPORT FOR INDIA FOR THE MONTH OF JANUARY 2016

This report is based on the information received from various State and Central drug law enforcement agencies till the end of January 2016. Significant seizures effected earlier but reported during January 2016 are also incorporated in this report.

SEIZURES EFFECTED IN THE MONTH OF JANUARY, 2016

- On 01.01.2016, officers of NCB, Jammu Zonal Unit seized 525 gram of Hashish at Kanchak, Jammu. 01 person was arrested.
- On 03.01.2016, officers of BSF, 24th Bn., BOP Sasani, Malda, West Bengal seized 3.050 kg of Opium and handed it over to NCB's, Kolkata Zonal Unit for further investigation under NDPS Act. 03 persons were arrested.
- On 04.01.2016, officers of NCB, Lucknow Zonal Unit seized 312.045 kg of Ganja at Nawabganj, Allahabad. 08 persons were arrested.
- From 04.01.2016 to 07.01.2016, officers of NCB, Imphal Sub Zone along with local administration destroyed illicit cultivation of Opium Poppy spread over 14 acres of land at Village Phaisi, District Chandel of Manipur.
- On 05.01.2016, officers of NCB, Kolkata Zonal Unit seized 650 kg of Poppy Straw and 190 kg of Poppy Pods at Burdwan.
- On 06.01.2016, officers of BSF, 191 Bn., Khemkaran, Punjab seized 4.880 kg of Heroin and 850 gram of Opium and handed it over to NCB's, Chandigarh Zonal Unit. The suspected source of the seized drug was South West Asia.
- On 08.01.2016, officers of NCB, Mumbai Zonal Unit intercepted a vehicle at Charoti Toll Naka, Palghar and seized 36.000 kg of Hashish. The drug was concealed in false cavity of back seat of the vehicle. 04 persons were arrested.
- On 08.01.2016, officer of 137 Bn. BSF, Mamdot, Punjab seized 900 gram of Heroin and handed it over to NCB's Amritsar Sub Zone for further investigation under NDPS Act. The suspected source of the seized drug was South West Asia.
- On 10.01.2016, officers of the Directorate of Revenue Intelligence, Gorakhpur intercepted a vehicle at near Gorakhpur Toll Plaza and seized 205.900 kg of Hashish. 05 persons were arrested. The suspected source of the seized drug was Nepal.
- On 11.01.2016, officers of the Central Bureau of Narcotics, Gwalior seized 20,000 injections (2 ml each) of Diazepam at Navdeep Travels, Lakkadkhana, Gwalior. 01 person was arrested.
- On 12.01.2016, officers of NCB, Lucknow Zonal Unit seized 30.000 kg of Hashish at Jafrabad Mod, Rudrapur-Rampur Highway, PS Bilaspur, District Rampur. 03 persons including 01 Nepalese national were arrested. The suspected source of the seized drug was Neapl.
- On 12.01.2016, officers of NCB, Guwahati Zonal Unit in the presence of Drug Disposal Committee disposed off 719.85 kg tablets of Pseudoephedrine, 1100 bottles of Phensedyl Cough Syrup and 7028 capsule of Spasmo Proxyvan at M/s Fresh Air Waste Management Service Pvt. Ltd., Khankar, Panikhaiti, Kamrup (Metro), Assam.
- On 13.01.2016, officers of NCB, Imphal Sub Zonal Unit along with 'G' team BSF busted an illegal Clandestine Laboratory & seized 1.500 kg of Morphine, 3.000 kg of Opium, 20.510 kg of Ammonium Chloride and 05 Tin of Lime Powder along with equipments of laboratory at Saikul bazaar, District Senapati, Manipur. 01 person was arrested.
- On 13.01.2016, officers of NCB, Guwahati Zonal Unit seized 1427 (940 gram) capsules of Spasmo Proxyvon and 52 bottles of Cough Syrup along with Indian currency of Rs. 51,014/- at Guwahati. 02 persons were arrested.

- On 13.01.2016, officers of NCB, Ahmedabad Zonal Unit seized 3.955 kg of Hashish near RTO Circle, Ahmedabad. 02 persons were arrested.
- From 13.01.2016 to 25.01.2016, officers of NCB, Kolkata Zonal Unit along with State Excise and State Police destroyed illicit cultivation of Opium Poppy spread over 2,525 Bighas of land in district Malda, West Bengal.
- On 14.01.2016, officers of NCB, Delhi Zonal Unit intercepted 02 parcels and seized 1.395 kg of Methaqualone and 43 gram of Pseudo Ephedrine. The suspected destination of the seized drug was Australia.
- On 18.01.2016, officers of NCB, Bangalore Zonal Unit seized 20 kg of Ephedrine at Kempegowda International Airport, Bangalore. 01 Namibian national was arrested. The suspected destination of the seized drug was South Africa.
- On 18.01.2016, officers of NCB, Mumbai Zonal Unit intercepted a parcel at M/s First Flight Courier Ltd. Andheri West and seized 480 gram of Heroin. The drug was concealed in stripes of Ghaghra Choli. The suspected destination of the seized drug was USA.
- On 24.01.2016, officers of the State Police, Andhra Pradesh intercepted a vehicle at Polluru Y-Junction, Chintoor Circle, E.G. District and seized 927 kg of Ganja. 01 person was arrested.
- On 25.01.2016, officers of NCB, Delhi Zonal Unit seized 150 Bottles of Phensydyl Cough Syrup at IGI Airport, New Delhi. 01 person was arrested. The suspected destination of the seized drug was Bahrain.
- On 27.01.2016, officers of NCB, Ajmer Sub Zone seized 27.500 kg of Poppy Straw at Ajmer Railway Station.
- On 28.01.2016, officers of NCB, Lucknow Zonal Unit seized 138 gram of Heroin at near Main Gate of Rafi Ahmad Kidwai District Hospital, Barabanki. 02 persons were arrested.
- On 28.01.2016, officers of NCB, Kolkata Zonal Unit seized 900 gram of Heroin from a parcel at BSF, BOP DMC, at Lalgola, Murshidabad, West Bengal.
- During the month of January, 2015, officers of the Customs, FPO, Kotla Road, New Delhi intercepted 03 parcels at Foreign Post Office and 2.460 kg of Ketamine. The suspected destinations of seized drugs was United Kingdom.
- During the month of January, 2015, officers of the Sashatra Seema Bal (SSB) seized 41.530 kg of Hashish, 80 gram of Heroin and 1698.730 kg of Ganja in 22 cases and arrested 14 persons including 05 Nepalese nationals. The suspected source of the seized drugs in most of these cases was Nepal.
