
OFFICE MEMORANDUM

Subject: Notifications under the Narcotic Drugs and Psychotropic Substances (NDPS) Act, 1985- regarding

The undersigned is directed to enclose herewith the following notifications for information and necessary action:

- (i) S.O. 1382(E) dated 02.05.2017 notifying Acetylfentanyl and MT-45 and its salts and preparations thereof to be manufactured drug under sub clause (b) of clause (xi) of section 2 of the NDPS Act, 1985.
- (ii) S.O. 1383(E) dated 02.05.2017 notifying five substances viz. [1] para-Methoxymethylamphetamine, PMMA [2] α--Pyrrolidinovalerophenone, α-PVP [3] para-Methyl-4- methylaminorex, 4,4'-DMAR [4] Methoxetamine, MXE and [5] Phenazepam their salts and preparations as 'psychotropic substance' under the NDPS Act, 1985;
- (iii) S.O. 1384(E) dated 02.05.2017 notifying the 'small' and 'commercial' quantities of the afore mentioned 7 substances.
- (iv) Notification No. G.S.R. 428(E) dated 02.05.2017 to place all the five psychotropic substances under Schedule I of the NDPS Rules, 1985.

2. Narcotics Control Bureau (NCB) being the coordinating agency for all the drug law enforcement agencies in the country is requested to inform all the enforcement agencies to sensitize their officers about the aforesaid notifications.
