From the Desk of DIRECTOR GENERAL

I am pleased to present the Annual Report, 2018 for the Narcotics Control Bureau. The report summarizes the various aspects of the drug law enforcement activities undertaken by NCB as the nodal agency of the Government of India. It also highlights the national perspective on narcotics and psychotropic substances, trafficking trends, emerging areas of concern and international drug trafficking scenario.

The changing paradigm of the global drug trafficking places India in a spot which characterizes it both as a source as well as a transit country. The ever changing challenges for the drug law enforcement agencies are multi-dimensional. The counter narcotic efforts are on strong foundations and NCB has amply demonstrated its capacity to deal with emerging challenges.

The spillover effect of the Afghan Heroin heading for Asian market poses additional challenge in terms of geographical proximity as well as networks of overseas drug groups targeting India as a transit base. The seizure of 1258 Kg of Heroin has significant share of Afghan variety smuggled from across the Indo-Pak border. 3911 Kg of Hashish seized, which is higher compared to last few years. The seizure of Cannabis (Ganja) has also increased from previous years.

The "in-baggage" and "on-person" are frequently used concealment methods for the transportation of heroin. The other methods like "swallowers" and "body-cavity" are also on the rise. These trends are indicative of the strong network of drug traffickers in the region. It has been NCB's constant foray into the realm of international cooperation for sharing actionable intelligence in real time.

NCB's ongoing commitment is reflected in the international arena by placing India in the forefront of the global fights against drugs. These commitments have been translated pragmatically through several Joint Working Groups meetings with countries sharing mutual concern and goal. The efforts are further buttressed by Bilateral Agreements to engage other countries on a common agenda.


The changing dynamics of organized crimes is a constant battle for drug law enforcement agencies and I am sure NCB shall continue to strive forward and receive the cooperation of all concerned.

DRUG TRAFFICKING SCENARIO IN INDIA



The drug trafficking scenario in India is largely attributed to various external and internal factors. One of the prime external factors happens to be India's close proximity to the major Opium producing regions of South West and South East Asia known as the 'Golden Crescent' and the 'Golden Triangle', respectively. The geographical location of India as such, makes it vulnerable to transit, trafficking and consumption of Opium derivatives in various forms along the known trafficking routes. The major internal factors responsible are illicit cultivation of Poppy and the diversion from the opium sources into illicit production in interior arears.



DRUG TRAFFICKING SCENARIO IN INDIA

One of the critical factors that impacts drug trafficking in any country, is its geographical location. India is no exception. For long, India has been susceptible to drug trafficking which is sourced to two of the most sensitive areas of the world referred loosely as the 'Golden Crescent' (Pakistan, Afghanistan and Iran) and the 'Golden Triangle' (Myanmar, Thailand and Laos). The illicit opium and heroin production in Afghanistan during the years 2017 and 2018 reached record levels. Consequently, there is a huge increase in trafficking of illicit opiates from Afghanistan to countries of the region namely India, Sri Lanka and Maldives. Every conceivable route and modus operandi is exploited by the traffickers to push in illicit heroin into India, the most significant of which being the maritime route.

Not surprisingly, the abuse of illicit opiates has emerged as the most significant cause of concern in India in the Drug Abuse Survey Report which was brought out by the Ministry of Social Justice & Empowerment (MSJE) earlier this year in the month of February. The MSJE carried out its first ever truly national survey on drug use in 2018, the results of which were published, early this year. The survey was based on the combined techniques of Respondent Driven survey

and Household survey from each State in the country with sample size of over 5 lakh. A prevalence of 2.1% of the population between the age group of 10 - 75 has been indicated for opiates which translates into 2.3 crore users of which 77 lakh are detected with problem use. The survey also reports that heroin is the most commonly used opioid in India (1.14%) followed by pharmaceuticals opioids (0.96%) and opium (0.52%). An extremely alarming aspect as reported by the survey is that prevalence of opioids abuse in India (2.06%) is over 4 times the Asian average (0.4.6%) and over 3 times the world average (0.70%).

1.1 TRENDS AND PATTERNS 2018

- The major drug trafficking trends in the country may be summarized as under.
- Trafficking of Heroin from South West Asia to India for possible internal consumption and again from India to other countries.
- Trafficking of Hashish from Nepal to India and from India to Nepal.
- Illicit cultivation of Opium and wild growth of Cannabis in some areas.
- Diversion of precursor chemicals and other controlled substances.

- Diversion of Ephedrine /Pseudoephedrine across Indo-Myanmar Border and reverse trafficking of Methamphetamine.
- Diversion of pharmaceutical preparations and prescription drugs containing psychotropic substances and trafficking to neighboring countries.
- Diversion of non-scheduled drugs / Ayurveda medicines and trafficking to Middle East, and other Western countries.
- Maritime Trafficking use of sea route for Trafficking of South West Asian Heroin from Pakistan, Afghanistan into India.
- Internet pharmacies and misuse of courier services.
- Use of dark net and bit coins in drug trafficking.
- Diversion of Opium from licit cultivation and indigenous production of low quality Heroin.
- Involvement of foreign nationals in trafficking and distribution networks.

1.2 NARCOTIC DRUGS

1.2.1 OPIUM

Papaver Somniferum, commonly known as the opium poppy, is a species of flowering plant in the family Papaveraceae. It is the species of plant from which opium and poppy seeds are derived. Opium is the coagulated juice of the Opium Poppy. It is a plant that grows in many countries around the world with moderate climate. Raw Opium is a non-homogeneous material containing


Poppy capsule fragments. It is sticky, tar-like and dark brown when fresh, and becomes brittle and hard as it ages. Raw Opium is produced by the air drying of Opium. Opium contains a class of naturally occurring alkaloids known as opiates that include morphine, Thebaine, Codeine, papaverine, Noscapine and oripavine. Heroin is synthesized from Opium.

Trends:


- Major trafficking of Opium is in Rajasthan,
 M.P., Bihar, Iharkhand and Gujarat.
- Trafficking from Rajasthan, U.P. and M.P. to other parts of country.

Total Opium seizures effected in 2018 were 4307 Kg. The comparative figures for the last 05 years are given below. While there has been an increasing trend in the number of reported Opium seizures in comparision to previous years, the quantity of Opium seized has also increased from 2551 Kg to 4307 Kg.

Significant seizures of Opium:

- On 01.01.2018, Officers of NCB, Delhi Zonal Unit seized 3.050 Kg of Opium at DHL Express Pvt. Ltd. Rama Road, Kirti Nagar Metro Station, New Delhi. The suspected destination of the seized drug was Canada.
- On 21.01.2018, Officers of NCB, Chandigarh Zonal Unit seized 3.850 Kg of Opium near Pinjore Bus Stand. Three persons were arrested.
- On 23.01.2018, Officers of NCB, Jodhpur Zonal Unit seized 21.100 Kg of Opium from a vehicle near Raja Dhok Toll Palaza, NH-11, Tehsil Bassi, Distt.- Jaipur. Two persons were arrested.
- On 25.02.2018, Officers of NCB, Chandigarh Zonal Unit seized 3.250 kg of Opium at Ludhiana, Punjab. One person was arrested.
- On O1.03.2018, officers of NCB, Jodhpur Zonal Unit seized 29.678 Kg of Opium in front of Bilara Police Station, Jodhpur. One person was arrested.
- On 09.03.2018, officers of NCB, Patna Zonal Unit seized 5.500 Kg of Opium. Two persons were arrested.
- On 29.03.2018, officers of NCB, Chandigarh Zonal Unit seized 4.050 Kg of Opium and 18.800 Kg of Poppy Straw at PS-

Parao, Ambala, Haryana. Three persons were arrested.

- On O9.04.2018, officers of NCB, Jodhpur Zonal Unit & NCB, Chandigarh Zonal Unit in a joint operation seized 55.100 Kg of Opium along with Indian currency of Rs. 18,44,600/- and two vehicles at village Chistiyan, Tehsil/Distt. Hanumangarh, Rajasthan. Five persons were arrested.
- On 11.04.2018, officers of NCB, Jodhpur Zonal Unit seized 56.850 Kg of Opium and 19.930 kg of Poppy Straw at Piplaz Toll Plaza, NH- 8, Beawar, Ajmer. Three persons were arrested.
- On O1.05.2018, Officers of NCB, Jodhpur Zonal Unit seized 21.230 Kg of Opium and 46.200 kg of Poppy Straw at Dausa, Rajasthan. One person was arrested.
- On 18.06.2018, officers of NCB, Jodhpur Zonal Unit seized 5.750 kg of Opium at Jodhpur and arrested 03 persons.
- During the month of May, 2018, Officers of the Sashastra Seema Bal (SSB) seized 4.400 kg of Opium, 30.480 Kg of Hashish, 58.850 kg of Ganja and 400 gram of Poppy Straw in 12 cases and arrested 17 persons including O5 Nepalese. The suspected source of the seized drugs in most of these cases was Nepal.
- On 09.07.2018, officers of NCB,

Kolkata Zonal Unit seized 4.700 kg of Opium at platform No. 1, New Jalpaiguri Railway Station. 01 person was arrested.

- On 15.10.2018, officers of NCB, Jodhpur Zonal Unit seized 20.562 kg of Opium at Toll Plaza Sikandra, Dausa, Rajasthan. Ol person was arrested.
- On 16.11.2018, officers of State Police, Shambupura, Chittorgarh, Rajasthan seized

- 100 kg of Opium at Ghatiyawati to Chittorgarh Road. O2 persons were arrested.
- On 08.12.2018, officers of Customs, Lucknow seized 71.500 kg of Opium at Lucknow. 02 persons were arrested.
- On 08.12.2018, Officers of Customs, Lucknow seized 71.500 Kg of Opium at Lucknow. Two persons were arrested.


1.2.2 HEROIN

Heroin is a semi-synthetic drug which is derived from opium. It is also known as di-acetyl morphine. It comes out in a variety of colours, ranging from white & ivory to dark grey. The South West Asian origin heroin that enters India through various modes and routes has a higher level of purity in comparison to the locally produced variety. The purity decreases as it passes through a number of hands to the streets due to successive levels of adulteration.




Trends:-

- South West Asian Heroin accounts for around _____% of total Heroin seized in India
- Major trafficking of Heroin in India takes place through India-Pakistan border through bordering states of Punjab and Jammu & Kashmir. From these bordering states Heroin is trafficked into other states.
- Recent trend of increase in Maritime trafficking of South West Asian Heroin through sea.
- Trafficking through air route is mainly between Kabul and Delhi.
- Substantial quantity seizures of have been effected in Punjab, J&K, Himachal Pradesh, Gujarat, Delhi, West Bengal and UP.

• Significant seizures of Heroin:

- On O4.01.2018, officers of Special Cell, Delhi Police seized 2.000 kg of Heroin near Shani Mandir, Vikas Puri, New Delhi. O1 Nigerian national was arrested
- On 07.01.2018, officers of NCB, Amritsar Sub Zone in coordination with BSF Gurdaspur, Punjab seized 18.800 kg of

Heroin. The suspected source of the seized drug was South West Asia.

- On 14.01.2017, officers of NCB, Patna Zonal Unit seized 3.200 kg of Heroin nearby Suboli Railway Station. O2 persons were arrested. The suspected destination of the seized drug was Nepal.
- On 31.01.2018, officers of NCB,

Kolkata Zonal Unit seized 3.000 kg of Heroin at Gatepara, Gobindapur, on NH-24, PS-Kaliganj, Nadia, West Bengal. O2 persons were arrested.

- On O4.02.2018, officers of NCB, Amritsar Sub-Zone seized 7.925 kg of Heroin which was handed over by 118 Bn. BSF, Jalalabad, Punjab.
- On 13.02.2018, officers of NCB, Delhi Zonal Unit seized 4.800 kg of Heroin at IGI Airport New Delhi. O1 Tanzanian National was arrested.
- On 20.02.2018, officers of NCB, Mumbai Zonal Unit seized 1.330 kg of Heroin at Borivali Railway Station, Mumbai. Ol Uganda national was arrested.
- During the month of February, 2018, officers of the Sashastra Seema Bal (SSB) seized 1.775 kg of Heroin, 18 gram of Morphine, 45.446 kg of Hashish, 415.600 kg of Ganja and 347 kg of Poppy Straw in 21 cases and arrested 18 persons including 07 Nepalese. The suspected source of the seized drugs in most of these cases was Nepal.
- On 07.03.2018, officers of NCB, Ahmedabad Zonal Unit apprehended a Nigerian person from Mumbai Rajdhani Express at Vadodara Railway Station and seized 1.210 kg of Heroin. The drug was concealed in 03 steel boxes. He was

arrested.

- On 14.03.2018, officers of NCB, Imphal Sub Zone in coordination with Assam Rifles seized 1.865 kg of Heroin and 10.270 kg tablets of Methamphetamine at Assam Rifles, Khudengthabi Check Post, Tengnoupal, Manipur. O1 person was arrested.
- •On 15.03.2018, officers of NCB, Amritsar Sub Zone in coordination with BSF, Khasa, Amritsar seized 10.750 kg of Heroin. The suspected source of the seized drug was South West Asia.
- On O6.O4.2O18, officers of NCB, Amritsar Sub Zone in coordination with BSF, Khasa, Amritsar, Punjab seized 3.980 kg of Heroin. O1 Pak national smuggler was arrested and O1 Pak national smuggler was killed during operation, body of which was handed over to PS Lapoke, Amritsar, Punjab. The suspected source of the seized drug was South West Asia.
- On 14.04.2018, officers of Delhi Police seized 3.000 kg of Heroin at Maidan Garhi, New Delhi. O1 Nigerian national was arrested. The suspected destination of the seized drug was Sri Lanka.
- On 25.05.2018, officers of NCB, Delhi Zonal Unit seized 3.000 kg of Heroin at IGI Airport New Delhi. Ol Tanzanian national was arrested.

- On 23.06.2018, officers of NCB, Amritsar Sub Zone in coordination with BSF, Khemkaran, Punjab seized 1.115 kg of Heroin. The suspected source of the seized drug was South West Asia.
- On 28.06.2018, officers of NCB, Amritsar Sub Zone in coordination with BSF, Ajnala, Amritsar, Punjab seized 1.230 kg of Heroin. The suspected source of the seized drug was South West Asia.
- On O1.07.2018, officers of NCB, Amritsar Sub Zone in coordination with BSF, BOP Rear Kakkar, Ramtirath, Punjab seized 2.000 kg of Heroin. The suspected source of the seized drug was South West Asia.
- On 24.07.2018, officers of Delhi Police seized 2.000 kg of Heroin at Malviya Nagar, New Delhi. O1 Afghani national was arrested.
- On 30.07.2018, officers of Delhi Police seized 4.500 kg of Heroin at New Delhi. O2 persons were arrested. Further in follow up operation 750 gram of Heroin was seized at Uttam Nagar, New Delhi. O1 Nigerian national was arrested. Total 5.250 kg of Heroin was seized.
- On O6.08.2018, officers of NCB, Jammu Zonal Unit in a joint operation with J&K Police and seized 50.300 kg of Heroin from a vehicle. O2 persons were arrested. The suspected source of the seized drug was

South West Asia.

- On 19.08.2018, officers of NCB, Amritsar Sub Zone in coordination with BSF, Joginder, Ferozpur, Punjab seized 5.900 kg of Heroin. The suspected source of the seized drug was South West Asia.
- On 14.09.2018, officers of NCB, Amritsar Sub Zone in coordination with BSF Punjab seized 6.542 kg of Heroin. The suspected source of the seized drug was South West Asia.
- On 15.09.2018, officers of NCB, Amritsar Sub Zone in coordination with BSF, Punjab seized 4.500 kg of Heroin. The suspected source of the seized drug was South West Asia.
- On 18.09.2018, officers of Delhi Police seized 5.000 kg of Heroin along with US \$ 4200 at Saket, New Delhi. 02 Afghani & 01 Nigerian were arrested.
- On O6.11.2018, officers of NCB, Jammu Zonal Unit seized 50.120 kg of Heroin from a vehicle at Ban Toll Plaza, Jammu. O1 person was arrested. The suspected source of the seized drug was South West Asia.
- On 27.12.2018, officers of NCB, Amritsar Sub Zone in coordination with BSF, Bheropal, Punjab seized 5.130 kg of Heroin. The suspected source of the seized drug was South West Asia.



- On 2nd September, 2018 Narcotics Control Bureau, Jammu working on an intelligence input affected a major seizure of 22.145 Kg of Heroin and arrested three persons after a long chase of a Santro car at Palli more, Lakhanpur, Jammu. During preliminary investigation arrested persons revealed that the drug was originated from Handwara (Kashmir) and destined to Jalandhar (Punjab). On the basis of information revealed from arrested persons, NCB conducted simultaneously operations in Jarnmu, Punjab and Kashmir.
- On 03rd & 04th September, 2018 team of NCB Jammu, NCB Amritsar Sub Zone and Punjab Police intercepted and arrested Paramjit Singh r/o Rudiwala, Tarntaran, Amritsar (receiver of the seized Drug) along with one vehicle and cash of Rs 17,49,400/-. The recovered cash was brought by him for payment of heroin. Further, on 04th September, 2018 NCB Amritsar and Punjab Police conducted House search of Paramjit Singh R/o Vill Roriwala, PS Chola Sahib, Tarn Taran (Punjab) and recovered unaccounted cash of Rs.5,00,000/- and other documents.
- Again on 05th Sep 2018 in follow up action, team of NCB Jammu seized 38.07 kg heroin from the house of arrested person in militancy affected area of Handwara, Kashmir with the support of J&K police. The summary of achievement is as follows -
 - ? Arrested 04 persons including carrier and receiver.
 - ? Seized approx. 60 kg Heroin (22.145 kg + 38.07 kg)
 - ? Recovery of Cash Rs.22, 49,400/-.
 - ? Seized 02 cars.
- This is the biggest seizure of Heroin in this year by any agency in India. With the arrest of carriers and receiver of the drugs along with major hauls of drugs, vehicles as well as cash, nexus of the drug traffickers exposed and foiled their attempts of drug smuggling in the present scenario.


1.2.3 CANNABIS (GANJA)

Cannabis is a genus of flowering plants in the family Cannabaceae. Cannabis, produced from the Cannabis sativa plant, is used in three forms: herbal Cannabis, the dried leaves and flowering tops. Cannabis is also known as 'Ganja,' or 'Weed'. Cannabis resin, the pressed secretions of the plant, known as 'Hashish' or 'Charas;' and Cannabis oil, a mixture resulting from distillation or extraction of active ingredients of the plant.




Trends

- Trafficking from the North-East India to eastern states is mainly by surface transport.
- Trafficking in substantial quantities takes place across India Nepal border and in the states of West Bengal, Uttar Pradesh, Andhra Pradesh and Odisha.
- The main transit routes for Ganja are through Assam, Odisha, West Bengal, Bihar, Uttar Pradesh, Nagaland and Chhattisgarh.

• Significant seizures of Ganja:

- On 05.01.2018, officers of NCB, Patna Zonal Unit seized 155 kg of Ganja from a vehicle at Musrigharari Chowk, Samastipur. 03 persons were arrested.
- On O9.01.2018, officers of NCB, Maduari Sub Zone seized of 350 kg of Ganja from a truck at Valavathankottai Toll Plaza, Thuvakudi, Trichi. O3 persons were arrested.
- On 01.02.2018, officers of Directorate of Revenue Intelligence,

Agartala in coordination with BSF 130 Bn., Ambassa, Dhalai, Tripura seized 1137.400 kg of Ganja. O1 person was arrested.

- On 18.02.2018, officers of NCB, Lucknow Zonal Unit seized 565 kg of Ganja at Kanpur. 02 persons were arrested.
- During the month of February, 2018, officers of the Sashastra Seema Bal (SSB) seized 1.775 kg of Heroin, 18 gram of Morphine, 45.446 kg of Hashish, 415.600 kg of Ganja and 347 kg of Poppy Straw in 21



cases and arrested 18 persons including O7 Nepalese. The suspected source of the seized drugs in most of these cases was Nepal.

- On 17.03.2018, officers of Meghalaya Police, Ri-Bhoi seized 1000.130 kg of Ganja at G.S. Road, Ri-Bhoi district, Meghalaya. Ol person was arrested.
- On 17.03.2018, officers of Directorate of Revenue Intelligence, Guwahati seized 1040 kg of Ganja at Khanapara, Guwahati. 02 persons were arrested.
- On 29.03.2018, offices of NCB, Patna Zonal Unit seized, 1115 kg of Ganja at Nadi Than, Patna. 03 persons were arrested.
- On 09.04.2018, officers of NCB, Patna Zonal Unit seized 1029.500 kg of Ganja at Patna. 02 persons were arrested.
- On 26.05.2018, officers of NCB, Bhuwaneswar Sub Zone in coordination with NCB, Hyderabad Sub Zone, CIC, Andhra Pradesh Police seized 1598 kg of Ganja at Malkangiri, Odisha. O2 persons were arrested.

- On 27.05.2018, officers of NCB, Lucknow Zonal Unit seized 2283.300 kg of Ganja at Naubasta bye-pass, Kanpur. O2 persons were arrested.


1.2.4 CANNABIS (HASHISH)

• Hashish, or Charas, is a drug made from cannabis. Hashish is cannabis resin. Generally Hashish is extracted from the plants by rubbing the flowering tops of the plant between the palms of the hand or on rubber sheets.




Trends:

- Charas/Hashish is derived from the illicit cannabis cultivation being done by the drug traffickers at Kashmir Valley especially in the districts of South Kashmir and Kullu in Himachal Pradesh.
- There is a trend of trafficking of Charas from Kashmir to Maharashtra, Rajasthan, Goa & Gujarat.
- Charas is also trafficked from Nepal to India.


1.2.5 COCAINE

Cocaine is a powerfully addictive stimulant drug made from the leaves of the coca plant native to South America. As a street drug, cocaine looks like a fine, white, crystal powder. The primary markets are North America and Europe. In India, cultivation of coca plant is not done. However, Cocaine is mainly smuggled in by West African drug traffickers.

Trends:

- Smuggling of cocaine is mostly being done by African nationals based in India.
- Instances of Cocaine being smuggled from Argentina, Brazil and South America have also come to notice.
- Seizures of Cocaine in India have been made at airports mostly.
- There are many instances of small quantities of Cocaine trafficking through parcels concealed in common household articles like cosmetics, utensils, books and clothing.
- The latest trend is trafficking of Cocaine in liquid form.

TRAFFICKING ROUTES- COCAINE





- Acting on specific information received from a reliable source that a huge quantity of Cocaine was going to be delivered by a Nigerian national, aged about 28 years, in-front of City Center-2, Action Area-IID, New Town, Kolkata, on 04.01.2018, a team of NCB Officers of Kolkata Zonal Unit mounted surveillance and arrested the Nigerian national and seized 170 Grams (gross) Cocaine from his possession.
- He revealed in his statement that the drugs was brought to India by swallowing and concealing inside the body cavity and further sold to the customers and local peddlers in different cities in India. He further stated that he arrived in Kolkata to hand over the consignment on behalf of his associates, who is running the drug racket from Mumbai. The ultimate recipient of these stimulant narcotics drug are the people from elite class of the society. He was arrested under NDPS Act'1985 (as amended) on 04.01.2018.

1.3 NARCOTIC CROPS


1.3.1 Licit Opium Poppy Cultivation

Licit Opium poppy cultivation takes place in a total of 16 districts distributed in the states of Madhya Pradesh, Rajasthan and Uttar Pradesh. For the crop year 2018-19, the districts of Mandsaur, Neemuch & Ratlam in Madhya Pradesh; Kota, Baran, Jhalawar, Chittorgarh, Pratapgarh, Udaipur & Bhilwara in Rajasthan and Barabanki, Lucknow, Faizabad, Shahjahanpur, Budaun & Bareilly in Uttar Pradesh have been notified as the tracts within which the licit Opium cultivation in the country is to be undertaken. Licenses to grow opium are issued by the Central Bureau of Narcotics (CBN) to cultivators who meet the general


conditions required by the Government. During the crop year 2018-19 6983 Hectares area was licensed by CBN for cultivatin of licit opium poppy but due to bad weather and diseases, 85% of poppy crop damaged. It is estimated that, approximately only 20% of the area licensed i.e about 1050 hectares has been harvested as per CBN reporting.

1.3.2 ILLicit Opium Poppy Cultivation

During 2018, illicit cultivation of opium poppy was found in the states of West Bengal, Arunachal Pradesh, Manipur, Uttarakhand, Jharkhand, Bihar, Jammu & Kashmir, Maharshtra and Himachal Pradesh.



1.3.3 Illicit Cannabis Cultivation

• Under the NDPS Act, the cultivation of Cannabis is illegal except in accordance with conditions of a license, permit or authorization as provided under Section 8 of the NDPS Act, 1985. One of the important countermeasures undertaken by NCB is to identify and destroy illicit cultivation of the plant. In 2018, the area under illicit cannabis cultivation was detected to be around 8476 acres, which was subsequently destroyed by various Central & State agencies.


1.4 PSYCHOTROPIC SUBSTANCES

- According to the NDPS Act, "psychotropic substance" means any substance, natural or synthetic, or any natural material or any salt or preparation of such substance or material included in the list of psychotropic substances specified in the Schedule. The Schedule includes substances like ATS, Methamphetamine, Methaqualone, Alprazolam, Diazepam, Buprenorphine, etc. A synthetic opioid analgesic, Tramadol was included in the list of psychotropic substances, during the year 2018.
- Besides, the Government of India

notified <u>13</u> substances on 27th Februaray, 2018 under the NDPS Act, 1985. The details of which are as under:

1.4.1 Synthetic Drugs

The abuse of synthetic drugs is one of the fast emerging challenges for drug law enforcement agencies. Synthetic drugs like Amphetamine Type Stimulants (ATS) have become the drug of choice in South East Asia and in North America. In India, several attempts have been made in the past to set up clandestine manufacturing facilities, especially in Maharashtra and Gujarat to produce ATS.



Trends:

- Trafficking of ATS from Myanmar to India along North-Eastern Border States.
- Australia, Malaysia and Thailand are the major destination countries for ATS trafficking sourced from India.
- · USA, Australia, Malaysia and South Africa are the major destination countries for Methagualone/ Mandrax sourced from India.
- A major portion of Methaqualone/ Mandrax seizures are effected at Airports of New Delhi, Kolkata and Mumbai.

Significant seizures of Methaqualone:

- On 25.06.2018, officers of Directorate of Revenue Intelligence, Kolkata seized 4.697 kg of Methaqualone at Kolkata. O2 persons were arrested.
- On 27.06.2018, officers of Directorate of Revenue Intelligence, Mumbai seized 30 kg of Methaqualone and 29 tablets of Tramadol from a parcel at M/s EICI Courier Terminal Sahar, Mumbai. The suspected destination of the seized drug was USA.
- On 20.07.2018, officers of NCB, Delhi Zonal Unit seized 25 gram of Methaqualone at IGI Airport, New Delhi. 01 person was arrested.

Significant seizures of Amphetamine Type Stimulants (ATS):

- trafficking is done mainly through Delhi, Chennai, Cochin and Airports.
- There are instances of use of courier/parcels also.

- On 25.10.2018, officers of NCB, Delhi Zonal Unit seized 14.500 kg of Pseudo Ephedrine at IGI Airport, New Delhi. Further in follow up 01 Malawian national was arrested at IGI Airport, New Delhi on 26.10.2018. The suspected destination of the seized drug was Adis Ababa.
- On 15.11.2018, officers of NCB, Delhi Zonal Unit seized 15.000 kg of Pseudo Ephedrine at IGI Airport, New Delhi. 01

Zimbabwean national was arrested. The suspected destination of the seized drug was Zimbabwe.

• On 14.12.2018, officers of NCB, Delhi Zonal Unit seized 25.200 kg of Ephedrine at Mahavir Enclave, New Delhi. O1 Nigerian national was arrested. The suspected destination of the seized drug was South Africa.

1.7 PHARMACEUTICAL DRUGS

• The abuse of pharmaceutical drugs in India has assumed serious proportions in recent times. The problem seems to be serious in the North-east and North-west region of the country. The pharmaceutical products that are abused include Buprenorphine, Codeine-based cough syrups, Alprazolam, Diazepam and other sedatives. The easy availability of such preparations is the major factor that encourages their misuse. There is also a perception that these pharmaceutical drugs

are less harmful than hard drugs like Heroin, Cocaine, etc. However, this is a misconception, since these can be addictive and also have a debilitating effect on health. Pharmaceutical preparations having narcotic / psychotropic substances are under the purview of the Drugs and Cosmetic Act, and the NDPS Act in India.

• Law enforcement agencies have also seized sizeable quantities of Alprazolam tablets, Zolpidem, Tramadol tablets, Stidonafil tablets, etc.



Significant seizures of Pharmaceutical Drugs (Tablets):

- On 12.02.2018, officers of NCB, Delhi Zonal Unit seized 200 tablets of Nitrazepam from a parcel at M/s DHL Express Pvt. Ltd., Kirti Nagar Metro Station, New Delhi.
- On 22.02.2018, officers of NCB, Dehradun Sub Zone seized 11175 tablets of Alprazolam and 616 tablets of Spasmo Proxywon Plus at Ganeshpur, Shimla Bypass Road, Dehradun. O1 person was arrested.
- On 14.03.2018, officers of NCB, Delhi Zonal Unit seized 5025 tablets of Zolpidem at M/s DTDC couriers & Cargo Ltd Ghaziabad. Further, in follow up operation conducted on 16.03.2018, NCB has also seized 50,850 tablets of Zolpidem. O4 persons were arrested.
- On 15.05.2018, officers of Central Bureau of Narcotics, New Delhi seized 145 bottles of Codeine based Cough Syrup, 3634 tablets of Tramadol, 1655 tablets of Nitrazepam and 1590 tablets of Alprazolam at Sanjay Gandhi Transport Nagar, Delhi. O1 person was arrested.
- On 22.05.2018, officers of Central Bureau of Narcotics, New Delhi seized 2,06,125 tablets of Alprazolam, 1,28,880 tablets of Tramadol, 31,260 tablets of Lorazepam, 20,400 tablets of Nitrazepam, 9,237 bottles of Cough Syrup, 7,800 tablets of Chlordiazepoxide, 6,050 ampoules of Buprenorphine, 3,194 ampoules of Pentazocine, 3,190 tablets of Clonazepam, 1400 tablets of Diazepam, 380 ampoules of Diazepam and 300 tablets of Zolpidem at Bhagirath Place, New Delhi. O1 person was arrested.

- On 29/30.05.2018, officers of Directorate of Revenue Intelligence, Vapi, Gujarat seized 6,66,90,600 tablets, 2129.340 kg of loose tablets and 869.630 kg of Powder of Tramadol along with machinery at Valsad, Gujarat. O2 persons were arrested.
- On 03.07.2018, officers of NCB, Madurai Sub Zone seized 1,07,100 tablets of Alprazolam, 97 bottles of Cough Syrups containing Codeine. 01 person was arrested.
- On 24.09.2018, officers of NCB, Kolkata Zonal Unit seized 108 tablets of Nitrazepam, 48 tablets of Tramadol, 305 tablets of Clonazepam, 187 tablets of Lorazepam, 440 tablets of Alorazolam and 1697 tablets of Zolpidem from a residential premise at Greenfield City, Maheshtala, Kolkata. O1 person was arrested. On 25/26.09.2018 in follow up operation NCB has also seized 210 tablets of Alprazolam, 88 tablets of Tramadol, 10 tablets of Nitrazepam and 60 tablets of Lorazepam along with Indian currency of Rs.2020/-. O2 persons were arrested.
- On 01.11.2018, officers of NCB, Delhi Zonal Unit seized 990 Tablets of Lorazepam, 450 tablets of Clonazepam, 600 tablets of Diazepam and 1980 tablets of Alprazolam at DHL Express, New Delhi. Further in follow up operation NCB seized 1020 Tablets of Lorazepam, 980 tablets of Clonazepam, 980 tablets of Diazepam, 1980 tablets of Alprazolam and 4980 tablets of Zolepidem at Pahar Ganj, New Delhi. O1 person was arrested. The suspected destination of the seized drug was USA.

1.8 INTERNET PHARMACY

- The emergence of illegal websites established in the USA, Europe etc. offering unregulated trade in a range of prescription medicines over the internet has taken firm root in India as a supplier. These online pharmacies transmit orders from paying customers to agents in India, who then procure the medicines from either legitimate or illegitimate sources before dispatching them to customers by mail and courier. The sheer volume of international post makes it impossible to screen every parcel and hence a vast majority of illegal consignments passes by undertacted by the authorities.
- Internet pharmacies are usually highly valnarable and keep the identity of organizers tightly veiled. In India, nevertheless, the NCB either on its own or in coordination with the outside agencies has been making atleast one bust every year over the years.
- On O2.08.2018, officers of NCB, Delhi Zonal Unit seized 6655 tablets of Daizapam, 5230 tablets of Zolpidam, 755 tablets of Clonozapam, 290 tablets of Alprazolam, 180 tablets of Nitrezapam, 9300 tablets of Tramadol and busted O1 illegal Internet Pharmacy at Gurgaon. The suspected destination of the seized drug was various countries. O1 person was arrested.
- On 17.08.2018 & 18.08.2018, officers of NCB, Delhi Zonal Unit seized 1.360 kg tablets of Diazapam, 955 gram tablets of Hydrocodone, 143 gram tablets of Adderal,

60 gram tablets of Xanex, 1260 tablets of Alprazolam, 5890 tablets of Lorezapam, 10640 tablet of Phentermine, 20100 tablets of VV DON Hydrocodone, 115 tablets of Clonorezapam, 356 of Suspected tablets and 3000 tablets of Lypin at Delhi NCR and busted 01 illegal Internet Pharmacy. 04 persons were arrested.

1.9 CONTROLLED DELIVERY

- Controlled Delivery is a technique which allows illicit or suspect consignments of Narcotics drugs and Psychotropic Substances, controlled substances or substances substituted for them to pass out of, or through or into the territory of India with the knowledge and under the supervision of an officer empowered in this behalf or duly authorized under section 50A with a view to identifying the persons involved in the commission of an offence under this Act:
- The Director General of Narcotics Control Bureau constituted under subsection (3) of section 4 or any other officer authorized by him in this behalf, may, notwithstanding anything contained in this Act, undertake controlled delivery of any consignment to:
- (a) any destination in India
- (b) a foreign country, in consultation with the competent authority of such foreign country to which such consignment is destined, in such manner as may be prescribed.



• During the year 2018, three Controlled Delivery Operations were conducted with the help of United Kingdom and USA.

1.10 DISPOSAL OF DRUGS

- Narcotics Control Bureau disposed off various narcotic drugs or psychotropic substances during the calendar year 2018 owning their vulnerability to theft, substitution, constraints of proper storage space which are reflected in a tabular form below.
- On 12.01.2018, officers of NCB, Guwahati Zonal Unit in the presence of board members of Drug Disposal Committee and other witnesses disposed off 759.144 kg of Ganja and 6441 bottles of Phensedyl Cough Syrup at M/s Fresh Air Waste Management Service Pvt. Ltd., Paikhaiti, Kamrup (M), Assam.
- On 17.01.2018, officers of NCB, Kolkata Zonal Unit in the presence of Drug Disposal Committee disposed off 138.401 kg of Acetic Anhydride at M/s Fresenius Kabi Oncology Limited, Kalyani, Nadia, West Bengal.
- On O5.O2.2018, a Drug Disposal Committee of Narcotics Control Bureau, Chandigarh Zonal Unit assembled at M/S Rainbow Environments Pvt. Ltd., Mohali, Punjab and destroyed 20.179 kg of Heroin, O5.134 kg of Poppy Husk, 41.926 kg of Charas. Again, 29.230 kg of Opium was deposited with the Government Opium and Alkaloid Works, Neemuch, M.P. These destroyed drugs were seized in 27 cases

- registered by NCB, Chandigarh Zonal Unit during the year 2015-17.
- On 13.03.2018, officers of NCB, Indore Zonal Unit & NCB, Mandsaur Sub Zone along with Drug Disposal Committee of disposed off 1886 kg of Poppy Straw, 19.100 kg of Ganja and 460 gram of Heroin at Vikram Cement Factory, Neemuch and 95.960 kg of Opium, 1.000 kg of Ganja and 250 gram of Heroin was deposited with Govt. Opium Alkaloid Factory, Neemuch.
- On 27.03.2018, officers of NCB, Kolkata Zonal Unit in presence of High Level Drug Disposal Committee disposed off 3.780 kg of Cocaine and 2694.954 kg of Ganja in respect of NCB Crime No. 31/2016, 23/2014 and 27/2017 at the common Bio-medical waste treatment facility Centre of Medicare Environmental Management Pvt. Ltd., Howrah facility at 41, 'F' Road, Belgachia, near HMC Dump Site, Howrah.
- On 23.05.2018, officers of NCB, Kolkata Zonal Unit in the presence of regular Drug Disposal Committee disposed off 1.948 kg of Heroin, 48.986 kg of Ganja, 27742 bottles of Phensedyl & other Cough Syrup, 119 gram of Methamphetamine and 352 gram of Suspected Powder in respect of NCB Crime No. 12/2015, 12/2016, 32/2016, 06/2017, 07/2017, 43/2016, 09/2004, 08/2017, 33/2016, 54/2017 and 03/2009 at the common Bio-medical waste treatment facility Centre of Medicare Environmental Management Pvt. Ltd., Howrah facility at 41, 'F' Road, Belgachia, near HMC Dump Site, Howrah.
- On 28.05.2018, officers of NCB,

Chandigarh Zonal Unit along with Drug Disposal Committee disposed off 25.903 kg of Heroin, 1.390 kg of Poppy Straw and 16.401 kg of Charas by way of burning in the incinerator at M/S Rainbow Environments Pvt. Ltd., Mohali, Punjab and 23.910 kg of Opium deposited with Government Opium and Alkaloid Works, Neemuch, MP.

- On 28.05.2018, officers of NCB, Kolkata Zonal Unit along with Drug Disposal Committee disposed off 770 gram of Heroin, 462.253 kg of Ganja, 449 gram of Diazepam and 1.747 kg of Suspected Powder at common Bio-medical waste treatment facility Centre of Medicare Environmental Management Pvt. Ltd., Howrah.

- On 11.07.2018 and 12.07.2018, Drug Disposal Committee of NCB, Ajmer Sub



- On 03.10.2018, officers of NCB, Bhubaneswar Sub-Zone in presence of regular Drug Disposal Committee disposed off 1229 kg of Ganja at the Sani Clean Pvt.Ltd, Tangiapada, Khurda, Odisha.
- On 10.12.2018, officers of NCB, Ahmedabad Zonal Unit along with Disposal Committee disposed off 53.652 Kg Charas, 614.91 Kg Ganja, 486 Grms Cocaine, 1.806 Kg Heroin, 1.220 Kg Methaqualone, 747 gram Methamphetamine, 65 gram MDMA, 404 gram Amphetamine at Bharuch Enviro Infrastructure Ltd, Ankleshwar.

2.1 TRAINING

Training programmes are conducted by Policy & Co-ordination wing of Narcotics Control Bureau, through a variety of channels. In India, the Officers working for drug law enforcement include officers from Central and State Government agencies which include the following;

- Narcotics Control Bureau
- Customs and Central Excise
- Department of Revenue Intelligence
- Border Guarding Forces
- State Police
- State Excise
- State Drug Controller, etc.

Common training requirements of the above mentioned agencies include, principal laws like Narcotic Drugs and Psychotropic Substances Act, 1985, PITNDPS Act, 1988, Regulation of Controlled Substances Order (RCS Order), 2013, Circular/ notifications, documentation procedures, emergence of New Psychoactive Substances (NPS), precursor control mechanism, collection of intelligence, National/ International trends in drug traicking, the study of reasons for acquittal of cases.

NCB conducts regular short duration training programmes for such field officials, either by itself or in co-ordination with other authorities like National Academy for Custom, Excise and Narcotics(NACEN), Intelligence Bureau(IB), Central Bureau of Investigation(CBI), North Eastern Police Academy(NEPA), National Institute of Criminology and Forensic Sciences(NICFS), Border Guarding Forces, State Police Training Centres, etc.

These programmes also provide a platform for sharing of best practices of the agencies in their respective areas of strength.

Some outcomes of such training are:

- Increase knowledge of drug law enforcement.
- Enhancement of professional skills in detecting/investigating drug offence cases.
- Enhancement of intelligence collection and analysis skills.
- Identification of the trends and patterns of drug traicking, and patterns and the dynamics of drug traicking, etc.
- Understanding, planning and executing "Controlled Delivery" Operations.
- Better understanding of drugs, precursors and clandestine labs.
- Knowledge of various interdiction techniques.
- NCB also provides 'resource persons' and training materials to other sister organizations like NACEN, CBI Academy, NICFS, BSF, SSB, NPA and State Police Academies for specialized training in drug law enforcement.

COMPUTER BASED TRAINING (CBT)

The Computer Based Training (CBT) is a part of UNODC Global e-Learning Programme which began in June 2010 for imparting training to the law enforcement oicers across the globe on various subjects related to drug trafficking. NCB has set up 12 CBT centres in coordination with UNODC at NCB Headquarters, New Delhi and NCB Zonal Units at Kolkata, Chennai, Bangalore, Chandigarh, Indore, Guwahati, Jodhpur, Lucknow, Jammu, Patna and Ahmedabad.

CBT modules cover all aspects of drug law

enforcement including intelligence, investigation, precursor traicking and anti money laundering. The CBT is a hands on training module, where a learner can learn by committing mistakes. The interactive nature of the modules facilitates enhanced retention.

The module has pre and post test scores/ sessions which enables the administrator to assess the impact of learning process.

During this period, NCB conducted 207 Training Programmes all over India. A total of 7,943 persons participated in the training programmes.

2.2 ASSISTANCE TO STATES

The grant under the "Assistance to States & UTs" scheme is subject to establishment of the following institutional mechanism:

- 1. Formation of an Apex Level Committee under the Chief Secretary/Senior Secretary of respective States/ UTs to draw up a strategy to combat both drug abuse and supply of drugs.
- 2. Setting up of an Anti Narcotics Task Force under an IG/DIG level officer.
- 3. Formulation of a 3/5-year Action Plan for the above purpose.

As per the scheme, financial assistance is given for procurement of items like Surveillance equipment, Laboratory equipment, Vehicle for patrolling/Surveillance, Computers and their accessories, Fax machine and photocopiers, Training equipment and other aids, Other equipment useful for enforcement.

The Scheme was initially launched during 2004-05, with a budget of Rs 10 crore for a period of five years. In 2009, the scheme was further extended for another five year term with an enhanced budget of Rs15 crore. Further, the scheme was extended for a period of three years viz. from 2014-15 to 2016-17 with budget of Rs. 15 crores.

NCB had requested MHA for extension of scheme "Assistance to States & UTs", for another term of five years. However, the same was extended by MHA, for another period of three years i.e. 2017-2020 with an estimated budget of Rs. 21 crores.

The implementation of the scheme is monitored by NCB. States that avail central assistance under this scheme are required to furnish performance reports and utilization certificates.

As on 31st December, 2018, financial assistance for Rs. 318,533,899/- has been provided to the States & UTs since start of the scheme in 2004.

2.3 DRUG DETECTION KITS

2.4 DRUG DEMAND REDUCTION

Demand Reduction refers to the steps taken by any agency to reduce demand for consumption of narcotic drugs or psychotropic substances. The demand reduction strategy is in addition to the supply reduction strategy which focuses on drug interdiction.

The Government of India has mandated the Ministry of Social Justice and Empowerment (MSJ&E) to run different demand reduction programmes.

The measures adopted for demand reduction include:

- Awareness building and educating people about harmful consequences of narcotic drugs
- Community-based intervention for identification, treatment, motivation, counselling and rehabilitation of drug addicts

Training of volunteers/service providers and other stake holders.

Demand Reduction Programmes by NCB:

Apart from its regular work in the field of drug interdiction, NCB does some work in spreading awareness among the masses by way of various programmes. These programmes include:

- Street Plays/ Cultural Programmes
- Run against drug abuse
- Display of Awareness Board in Pub, Bar and Airport, etc.
- Painting and slogan writing competition
- Pledge taking ceremonies
- Display of banners and posters at prominent public places
- Publication of Advertorial in leading newspaper
- Transmission of Anti-Drug Message through Radio channel
- SMS alert about drug awareness
- Observance of 26 June as 'International Day Against Drug Abuse & Illicit Traicking' to create awareness
- During 2018, NCB carried out 471 awareness and educational programmes as part of drug demand reduction activities across the country.



3.1 International Meetings / Conferences

3.1.1 Bilateral Meetings

The 3rd Director General Level Bilateral meeting between NCB India and CCDAC, Myanmar on Drug Control cooperation was held on 23.02.2018 at Yangon Myanmar. 3.1.3 JUDICIAL COOPERATION

a) Controlled Delivery Operations:

NCB conducts Controlled delivery operations in coordination with other countries. The Director General, Narcotics Control Bureau is empowered under Section 50A of the NDPS Act, 1985 to authorize "controlled delivery" of any contraband drugs to India or abroad.

b) Mutual Legal Assistance:

Mutual Legal Assistance Treaty (MLAT) is an agreement between two countries for gathering and transfer of evidence. Mutual Legal Assistance Treaty usually provides the framework to facilitate the widest measure of mutual assistance in:

- taking evidence or statements from persons;
- effecting service of judicial documents;
- executing searches and seizures;
- examining objects and sites;
- providing information and evidentiary items;
- providing originals or certified copies of the relevant documents and records including bank, financial, corporate, and business records;
- identifying or tracing proceeds, property, instrumentalities
- or other things for evidentiary purposes;
- The specific form of Mutual Legal Assistance that can be given or obtained depends on the provisions of the treaty with the foreign government.
- India has signed Mutual Legal Assistance Treaties with 39 countries namely Australia, Bahrain, Belarus, Bosnia & Herzegovina, Bulgaria, Canada, Egypt, France, Italy, Kazakhstan, Kuwait, Mauritius, Mexico, Myanmar, Mongolia, Russia, Singapore, Spain, South Africa, South Korea, Switzerland, Tajikistan, Thailand, Turkey, Ukraine, Uzbekistan, UAE, UK and USA.

c) Extradition:

- Extradition is the process of surrendering a fugitive residing in a country, who is wanted by the law enforcement of another country, after due process.
- India has extradition treaties with Bahrain, Belarus, Belgium, Bhutan, Bulgaria, Brazil, Canada, China, Croatia, Mauritius, Mexico, Mongolia, Nepal, the Netherlands, Philippines, Portugal, Poland, Russia, Spain, South Africa, South Korea, Switzerland, Turkey, Ukraine, UAE, Uzbekistan, UK and USA. Such treaties with several other countries have been negotiated.
- India has extradition arrangements on the basis of reciprocity with Sweden, Tanzania, Italy, Australia, Singapore, Sri Lanka, Papua New Guinea, Fiji and Thailand.
- The Indian Extradition Act contains a provision in terms of which extradition can be considered even in the absence of an extradition treaty if the ofence for which extradition has been sought is included in any international convention to which both India and the other country seeking extradition are parties.

3.1.4INCB/UNODC Reporting

Being a signatory to the various international conventions on narcotic drugs and psychotropic substances, India is under obligation to submit the required information to the United Nations oice of Drugs Crime (UNODC) and International Narcotics Control Board (INCB) in the prescribed formats. NCB is the nodal/central agency for

Narcotics Control Bureau

implementation of the India's obligations under various international conventions.

International Narcotics Control Board (INCB) To meet the international obligations under the UN Conventions on Narcotic Drugs, 1961, Convention on Psychotropic Substances, 1971 and United Nations Convention against Illicit traffic in Narcotic Drugs and Psychotropic Substances, 1988, NCB submits seven reports in the prescribed formats namely Form A, B, C, D, P, A/P and B/P to INCB Vienna. Form A& A/P relates to Import & Export of Narcotic Drugs and Psychotropic Substances, respectively, and the same are being submitted to INCB on quarterly basis. The other Forms i.e B, C, D & P is being submitted to INCB on an annual basis and relates to annual assessment/estimates of narcotics drugs and psychotropic substances in different fields. While Form B/P is being submitted once in 3 years which relates to annual assessment of medical and scientific requirement of scheduled substances. Inputs on the different Forms

come from Central Bureau of Narcotics (CBN), the Chief Controller of Factories (CCF) and the Drug Controller General ofIndia (DCGI).

United Nations Office on Drugs and Crime (UNODC)

Every member country has to provide inputs in the Annual Report Questionnaire (ARQ) every year on the working of the international drug control treaties to UNODC.

The ARQ has four parts detailed below:

Part-I Legislative and Institutional framework Part-II Comprehensive approach to drug demand & supply reduction

Part-III Drug Abuse situation, extent, pattern and trends of drug abuse Part-IV Illicit supply of drugs - Extent, pattern and trends in illicit drug cultivation, manufacture and Traicking.

Narcotics Control Bureau, being the National nodal agency for Drug Law Enforcement in India organized a two days' "National Conference on Drug Law Enforcement" on 23rd& 24th March, 2018. The purpose of the conference was to bring all the agencies working in the field of drug law enforcement on a common platform and to discuss the issues related to drug trafficking like trends in drug seizures, investigation techniques, best practices, recent developments, challenges etc.

The conference was inaugurated by, Hon'ble Minister of State (Home), Shri HansrajGangaramAhir. Officers from various State and Central Agencies participated in the conference. The valedictory speech was given by Hon'ble Home Minister, Shri Rajnath Singh. The Annual Report, 2017 of NCB was also released by the Hon'ble Home Minister on this occasion.

The Two-day Conference had eight sessions where speakers from various Government organizations both Central and State along

with their foreign counterparts had participated and delivered lectures on the following:

Resolutions of the Conference:

- 1. More funds should be provided by Govt. of India to scheme "Assistance to States & UTs for Narcotics Control".
- 2. More laboratories dedicated to testing drugs are required. MHA may consider establishing some.
- 3. More training institute/programme for Drug Law Enforcement training is required. Government of India may consider expanding its training offerings. More training material should also be created and made available to all agencies.

- 4. Reward money to State law enforcement personnel for detecting drug trafficking should be provided by Government of India/NCB at enhanced rates.
- 5. This conference may be made Annual Conference, held every year.
- 6. Drug detection kits with longer shelf life may be explored. Current shelf life of six months is not adequate.
- 7. All agencies resolved to pay more attention to conducting financial investigation in NDPS cases.
- 8. All agencies resolved to use PIT NDPS Act, (preventive detention law against narcotics smugglers) in appropriate cases.

4.ORGANISATION

4.1 NCB CHARTER

In exercise of powers under Section 4 of NDPS Act, 1985, the 'NARCOTICS CONTROL BUREAU' was constituted with Headquarters at Delhi with effect from 17th Mar, 1986. The Bureau, subject to the supervision and control of the Central Government, is to exercise powers and functions of the Central Government for taking measures with respect to:

Co-ordination of actions by various offices,

State Governments and other authorities under the N.D.P.S. Act, Customs Act, Drugs and Cosmetics Act and any other law for the time being in force in connection with the enforcement provisions of the NDPS Act, 1985.

Implementation of the obligation in respect of counter measures against illicit traffic under the various international conventions and protocols that are in force at present or which may be ratified or acceded to by India in future.

- Assistance to concerned authorities in foreign countries and concerned international organizations to facilitate coordination and universal action for prevention and suppression of illicit traic in these drugs and substances.
- · Coordination of actions taken by other concerned Ministries, Departments and Organizations in respect of matters relating to drug abuse.

On the recommendation of the Group of Ministers (GoM) on national security, NCB was transferred from Department of Revenue (DoR) to Ministry of Home Affairs (MHA) on 18.02.2003.

4.2 NCB ORGANISATION

The NCB was established in 1986, with a sanctioned strength of 164 and Zonal Units at Delhi, Kolkata, Chennai, Mumbai and Varanasi. Later new zones were sanctioned at Jodhpur, Chandigarh, Jammu, Ahmadabad, Indore, Guwahati, Patna and Bangalore whereas the Varanasi zone was shifted to Lucknow. Besides the oice of three Deputy Director Generals (Regional) were created,

one each in Delhi, Kolkata and Mumbai. Sub zones at Dehradun, Amritsar, Mandi, Ajmer, Ranchi, Bhubaneswar, Imphal, Goa, Mandsaur, Cochin, Madurai and Hyderabad has been created during last decade. At present, the sanctioned strength of NCB is 1107.

4.3 INFRASTRUCTURE/PROJECTS

Construction work of Office cum Residential complexes at Chandigarh and Ahmedabad Zonal Unit has been almost completed (more than 95%).

Land for construction of Office complex has been acquired at Delhi, Bangalore, Guwahati, Indore Zone, Bhubaneswar Sub-Zone, Ranchi and Amritsar Sub Zone.

Possession of land at Lucknow, Jammu and Amritsar for NCB Zonal Office cum Residential Complex is under process.

स्वापक संबंधी विषयों पर मौलिक पुस्तक लेखन पुरस्कारयोजना

ड्रग्स संबंधी विषय पर हिंदी में मौलिक पुस्तकें लिखने को बढ़ावा देने के उद्देश्य से स्वापक नियंत्रण ब्यूरो में मौलिक पुस्तक लेखन पुरस्कार योजना चालू है। इस योजना के अंतर्गत पुरस्कारों की राशि को आकर्षक बनाया गया है, जिसमें प्रथम पुरस्कार रूपए 1,00,000/-, द्वितीय पुरस्कार रूपए 75,000/-, तृतीय पुरस्कार रूपए 60,000/- व चतुर्थ पुरस्कार रूपए 30,000/- हजार राशि के रखे गए हैं। इसे ब्यूरो की वेबसाइट पर भी व्यापक प्रचार के लिए अपलोड करवाया गया।

प्रोत्साहन योजनाएं

मूल रूप से हिंदी में नोटिंग/ड्राफ्टिंग करने के लिए ब्यूरो में नकद पुरस्कार प्रोत्साहन योजना लागू है। राजभाषा विभाग, गृह मंत्रालय की उक्त योजना में ब्यूरो मुख्यालय से आठ दावे, दिल्ली क्षेत्रीय कार्यालय से १० दावे और कोलकाता क्षेत्रीय कार्यालय से १ और उप महानिदेशक (पूर्वीक्षेत्र), कोलकाता कार्यालय से ३ दावे प्राप्तक हुए। हिंदी में मूल टिप्पण/आलेखन नकद पुरस्कार योजना वर्ष २०१८—१९के लिए भी ब्यूरो में लागू की गई।

अधिकारियों द्वारा हिंदी में डिक्टेशन दिए जाने के लिए प्रोत्साहन योजना ब्यूरो मुख्यालय तथा सभी अधीनस्थ कार्यालयों में वर्ष २०१८ —१९के लिए भी लागू की गई।

अंग्रेजी के साथ साथ हिंदी में टंकण आशुलिपि कार्य करने हेतु प्रोत्साहन भत्ता

राजभाषा विभाग, गृह मंत्रालय की उक्त योजना के अंतर्गत ब्यूरो मुख्यालय से ०३ कार्मिकों तथा दिल्ली क्षेत्रीय कार्यालय से ०१ कर्मी को प्रोत्साहन भत्ता प्रदान किया गया।

हिन्दी पखवाडा आयोजन
