FOREWORD

I t gives me great pleasure to bring to you the annual report of the Narcotics Control Bureau for the year 2001-2002.

While compiling data on the licit aspects of cultivation and trade is a manageable task, the difficulties in trying to compile information on an illicit activity are well known. I hope the annual report serves as a reference for stimulating discussion and devising policy initiatives.

The year 2001 has been more than tumultuous. It has seen significant developments in terms of America's war on terrorism, the change of the Afghan Regime, all events that deeply impacted the international and domestic trafficking trends.

Within the country, the year 2001 saw significant amendments to the Narcotic Drugs and Psychotropic Substances Act, 1985, some of which have been adverted to in this report.

The need for dynamism in our approach to enforcement, better coordination among the Central and State Enforcement Agencies, and improved training techniques requires no emphasis.

While the Bureau shall attempt to focus on all these areas, I urge the State Police Organisations to dedicate adequate resources to and strengthen their focus on combating the menace of drugs. Not only do drugs pose a challenge to the victims and their families, the illicit trafficking has become a source of strength for criminal and terrorist organizations. The equation, tackling illicit trafficking = tackling crime, needs to percolate to bottom rungs of law enforcement.

I also take this opportunity to commend all the officials in law enforcement, demand reduction and de-addiction for their dedication. I also laud voluntary organizations, battling with the victims of substance abuse, for their commitment and efforts.

Lastly, I may mention that any suggestions on improving the content or any other aspect of the Annual Report would be highly welcome.

INTRODUCTION

India is a vast country with land borders extending over more than 15,000 kms, and a coast line of over 7000 Kms. India's narcotics problem arises from its geographical location. The country is flanked on either side by two regions which are internationally acknowledged as major sources of illicit Opiates. These are South West Asia (primarily Afghanistan and Pakistan) and South East Asia (Myanmar, Laos, Thailand). Nepal, a traditional producer of Cannabis, both herbal and resinous being the northern neighbour, adds a third dimension to the problem.

India is a traditional producer of licit opium for medicinal and scientific purposes. Several parts of the country provide a conducive climate for wild growth as well as cultivation of Cannabis. India also has a fairly advanced and large chemical industry manufacturing and using a wide range of chemicals for legitimate purposes. Some of these chemicals are also the precursors or essential chemicals required by the illicit drug industry and are, therefore, prone to diversion. The above facts and circumstances lie at the root of the drug trafficking scenario in the country.

There are also other challenges for drug law enforcement in India like the diversion of licitly produced opium and its conversion into heroin, the illicit cultivation of the opium poppy and cannabis plant, the clandestine manufacture of Methaqualone and Mandrax, the trafficking of hashish and ganja from Nepal, the diversion of precursors from both domestic, and international trade and the export trafficking of various drugs and precursor chemicals. A new problem is the trafficking of ATS from Myanmar into India.

The most important recent development ^ in the region which are relevant to the drug problem in India are the fall of Taliban regime in Afghanistan and the prohibition imposed by the new Afghanistan interim administration on the opium poppy cultivation and trade. The Afghan Government has the support of the international community in the matter. It is, however, still too early to say how these

developments would impact on the situation in India as this would primarily depend on the success of the Afghanistan Government in implementing the Narcotics policies on ground.

The most significant development relating to the domestic drugs scenario w.as the Amendment in NDPS Act made in October, 2001. These amendments, among other things, rationalize the sentence structure, establish me process of money laundering as a punishable offence and provide for the use for special investigating techniques such as Controlled Delivery.

STRATEGY AND POLICY

"he Narcotic Drugs and Psychotropic Substances Act 1985 sets out the statutory framework for drug law enforcement in India. This Act consolidated the erstwhile principal Acts, viz. the Opium Act 1857, the Opium Act 1878 and the Dangerous Drugs Act, 1930 and also incorporated provisions designed to implement India's obligations under various International Conventions. Certain significant amendments were made in the Act in 1989 to provide for the forfeiture of property derived from drugs trafficking and for control over chemicals and substances used in the manufacture of Narcotic drugs and Psychotropic Substances. In order to give effect to the statutory provisions relating to these substances, an order namely the N.D.P.S. (Regulation of Controlled Substances) Order was promulgated by the Government of India in 1993 to control, regulate and monitor the manufacture, distribution, import, export, transportation etc of any substance which Government may declare to be a 'controlled substance' under the Act. The statutory regime in India consequently covers drug trafficking, drug related assets as well as substances which can be used, in the manufacture of Narcotic Drugs and Psychotropic Substances. The Act has been further amended during 2001, the details of which are dealt in a separate section.

At the practical level the primary counter narcotics focus areas in India includes:-

- (a) Strict surveillance and enforcement at import points and the land borders.
- (b) Increased preventive and interdiction efforts along known drug routes.
- (c) Intensive control measures at export points, such as air-passenger terminals, cargo terminals and foreign post offices.
- (d) Improved co-ordination between the various drug law enforcement agencies in order to impart greater cohension and a multi-agency approach.
- (e) Identification of the illicit cultivation and the wild growth of cannabis and the opium poppy and the eradication of these sources of supply.
- (f) Strengthening of the intelligence apparatus to improve the collection, analysis and dissemination of operational intelligence.
- (g) Increased international co-operation, in intelligence investigations and mutual legal assistance.

TRAFFICKING TRENDS IN MAJOUR DRUGS

OPIUM

India is the world's sole licit producer of opium gum. A few other countries produce opium for extraction of alkaloids through the Concentrated Poppy Straw (CPS) route. Opium (Papaver somniferum) is licitly cultivated in India in the State of Rajasthan, Uttar Pradesh and Madhya Pradesh under a stringent licensing regime which is operated by the Central Bureau of Narcotics. An important element of this regime is the concept of a minimum qualifying yield which is stipulated each licensing year. The "Minimum Qualifying Yield" constitutes the eligibility threshold for a license in the following year.

During the 2000-2001 crop year licenses were given to 133409 cultivators for a total area of 26,684 hectares. However on account of drought and adverse weather conditions only 18106 hectares were actually planted by 102107 cultivators. The area actually harvested was 17155 hectares (96,435 cultivators) and the total yield was 935 M.T. (at 70% consistence) or 727 M.T. (at 90 consistence). The average yield per hectare was 45.947 kg. in Uttar Pradesh, 56.365 kg. in Madhya Pradesh and 57.105 kg. in Rajasthan against the Minimum Qualifying Yield of 44 kg. in Uttar Pradesh and 52 kg. in Madhya Pradesh and Rajasthan respectively.

During the 2001-2002 (October 2001- September 2002) crop season 133409 cultivators were licensed to grow the opium poppy in 26684 hectares. Of this, only 19373 hectares were actually planted and the crop failed in 1286 hectares. The actual area harvested was 18087 hectares and 726 tons of opium at 90 C or 934 at 70 C. The average yields was 56.37 kg. in Madhya Pradesh, 57.38 kg. in Rajasthan and 36.084 kg. in U.P.

Although an elaborate system of regulatory and preventive controls has been established to prevent the diversion of opium from the licit crop, certain quantities do flow into illicit channels. This is evidenced by seizures of opium in the poppy growing areas although an exact estimation of the quantum of diversion

is not possible. The obvious incentive for the farmer is the higher prices in the illicit market which range from Rs. 5000/- per Kg during the crop season in April to anywhere near Rs. 15000/- to Rs. 20000/- in December/January as compared to Govt.'s procurement prices which during 2001 ranged from Rs. 630/- to Rs.1400/- per Kg., depending on the quantity of opium tendered per hectare.

HEROIN

Heroin is the most problematic drug in the Indian context both in the extent of its abuse and its trafficking. Heroin sourced to South West Asia continued to dominate the trafficking scenario during the year. South East Asian heroin also continued to trickle into North Eastern India in small quantities from Myanmar primarily to meet local demand. There are also reports of diversions from India's licit opium crop for conversion into low grade heroin in small, make-shift manufacturing facilities mainly in the opium growing states of Uttar Pradesh, Madhya Pradesh and Rajasthan.

September 11 and its effect on world drug situation

The September 11 terrorist attack on the World Trade Centre in New York brought the World 's focus on Afghanistan and its role in terrorism and drug trade in the world. The military action in Afghanistan against the Taliban and the subsequent installation of a new regime has resulted in imposition of a ban on opium poppy cultivation and trade in the country. Although a ban has been imposed in the country, it will take time for the ban to be totally effective as large stocks of opium from previous years bumper crops are still available and the Afghan economy is based on a large part on drug money. Alternative development programmes will take time to have their effect.

An international effort code name "Operation Containment" has been launched by the affected countries to coordinate their efforts in the implementation of the ban in Afghanistan and interdiction of drugs originating in Afghanistan

India has taken effective steps for interdiction of drugs of SWA origin, the military build up at the Indo-Pak border has had an important role in reducing the influx of drugs from across the border. This reduction in flow of drugs of SWA origin into India has shown its effect on the prices of illicit drugs in the country which showed slight fluctuations but subsequently these have stabilized. This stabilization of prices could have come from the increase of supply of drugs of Indian origin.

There was no decline in the export trafficking of heroin through couriers operating out of the International Airports in Delhi and Mumbai. Reports also suggest the movement of South West Asian heroin into Bangladesh across the Indo-Bangladesh Border. The Southern Tamil Nadu coast around Tuticorin also continues to be exploited for the sea-borne smuggling of heroin into Sri Lanka.

The state wise break-up of these cases was Rajasthan 98.13 kg., Gujarat 53.9 kg., Delhi 225.49 kg., Maharashtra 55.06 kg., Punjab 22.27 kg., J&K 33.77 kg., Madhya Pradesh 56.57 kg. and Tamil Nadu 261.74 kg. These data indicate that the areas most vulnerable to smuggling are the north western states bordering Pakistan into which the drug flows and Maharashtra (Mumbai), Delhi and the Tamil Nadu coast through which the drug is smuggled out of the country. These trends are consistent with developments during the past few years. The most vulnerable areas along the Indo-Pakistan border were Amritsar in Punjab, Akhnoor and Kupwara in Jammu and Kashmir and Barmer in Rajsthan.

Total heroin seizures in the North Eastern States aggregated to 12.15 kg. in 2001 as against 10.28 kg. in 2000.

Emergence of Indo Sri Lanka sector as a major drug trafficking route During the year smuggling of Heroin from India to Srilanka continued and 262 Kgs of Heroin was seized in the Indo Srilanka Sector. A new modus operandi observed in the Indo-Srilanka was the appearance of swallowers. Several persons who had swallowed Heroin in the form of capsules were apprehended. The misuse of the coastline around Tuticorin as a staging point for the Heroin shipments of Srilanka continued. Investigations reveal that Srilankan Tamils have in collusion with their Indian counterparts established networks in Chennai, Bangalore, Mumbai and parts of Madhya Pradesh to run the Heroin trade. It is suspected that the Heroin smuggled to Sri Lanka is further transited to destinations in Europe and America.

Details of heroin seizures since 1996 are as follows:-

The discovery of a number of heroin processing facilities and investigations into seizures in various parts of the country confirm that some of the opium diverted from the licit crop is being processed into heroin in and around the opium growing areas.

HASHISH

5664 kg. of Hashish was seized in India during 2001. This is higher than the 2000 figure of 5041 kg. In terms of origin Kashmir has emerged as major source of Hashish seized in the country mainly in Gujarat and Maharashtra. Apart from Kashmir Hashish is being smuggled into India from Nepal across the land borders in the states of UP and Bihar from where it finds it way to Delhi and Maumbai. Hashish is also being domestically produced in Himachal Pradesh and western Ghat region in Kerala and tamil Nadu. Presence of large number of foreigners and their involvement in drug trade in Himachal Pradesh has further compounded the situation in the state.

METHAQUALONE

Seizures of Methaqualone have increased significantly during the last two years from 474 Kgs in 1999 to 1095 Kgs and 2024 Kgs in 2000 and 2001 respectively. This spurt in Methaqualone seizures is due to the resurgence of in illicit manufacture of methaqualone in the country. It has been observed that illicit manufacture has taken place in small scale pharmaceutical units which have all the infrastructure required for manufacturing, raw materials is available in the market and the precursors are procured

from illicit traders. This illicit manufacturing which was earlier limited to Maharashtra and Gujarat could take place in pharmaceutical belt in other parts of the country. Investigations reveal that the drug is generally smuggled to the African continent, south Africa remains the major destination. Methaqualone effected during the year 1996 to 2001 (upto March) are as follows:-

AMPHETAMINES

Amphetamines are not yet a significant problem in India both in terms of trafficking and consumption. Over the last two years, however small consignments of Amphetamines, have started entering India across the Indo-Myanmar Border. India has already, since December 1999 imposed controls under the NDPS Act on ephedrine and pseudo ephedrine in order to deny access to these chemicals to the illegal ATS industry in Myanmar. While the Indo-Myanmar border is vulnerable to the trafficking of both heroin and amphetamine there is a notable difference in that, while the heroin brought in from Myanmar primarly supplies local demand, Amphetamine moves further to metroplitan cities in India as well as to Nepal.

ACETIC ANHYDRIDE

India produces about 45000 M.T. of Acetic Anhydride every year for its pharmaceutical and dye industries. Strict controls have been imposed on this chemical both under the NDPS Act and the Customs Act. There has been a steady decline in seizures, of Acetic Anhydride since 1993 when it was declared as a 'controlled substances'. During 2001, 8589 lts. of Acetic Anhydride was seized in 8 cases as compared to 1337 lts. in 14 cases during 2000. During 2001 there were no seizures of Acetic Anhydride being smuggled either into Pakistan or into

Myanmar across the land borders and most of the cases related to domestic violations, particularly diversions for the manufacture of Methaqualone. Seizures of Acetic Anhydride effected during the year 1996 to 2001 are as follows:-

EPHEDRINE AND PSEUDO EPHEDRINE

India produces over 500 tones of ephedrine and pseudo ephedrine every year. Both these precursors were declared as "controlled substances" under the NDPS Act in December 1999. Consequently all manufacturers, traders and consumers of these chemicals are now required to maintain records file returns and comply with other restrictions under the NDPS Act. There was a significant fall in seizures of these chemicals from 1421 kg. in 1999 to 532 kg. in 2000. Seizures have, however, again picked up in the year wherein 930 Kgs of ephedrine was seized. A majority of these seizures relate to consignments destined for Myanmar, where a significant illicit ATS manufacturing industry reportedly exists. There were no reports of the diversion of ephedrine and pseudo ephedrine within India for the manufacture of ATS.

AMENDMENT TO NDPS ACT

The NDPS Act 1985 has been amended w.e.f. 2nd October,2001. The amendments now incorporated in the Act have brought about significant changes in the penal structure under the NDPS Act,1985 have made financial investigations and forfeiture of illegally acquired property more purposeful. In addition, provisions for new investigative techniques and removing certain practical difficulties faced by the investigating officers have been introduced.

THE AMENDMENTS ARE :-

Graded Punishments

The amended Act grades punishments into three categories depending on the quantity of drugs seized and also provides for judicial discretion as far as the severity of punishment is concerned. Violations relating to small quantities now attract imprisonment of up to six months or fine or both. Violations in respect of commercial quantities continue to attract a minimum prison sentence of 10 years which may extend to 20 years and shall also involve a fine of not less than Rs.1 lac which may extend to Rs.2 lacs. Any violations involving quantities of drugs more than prescribed the small quantities but less than commercial quantities shall be punishable with rigorous imprisonment for a term which may extend to 10 years and with fine.

Financial Investigations made easier

The property of a drug offender can after the amendments be frozen as soon as
he is arrested, without waiting for conviction or completion of the full period of
preventive detention.

Money laundering has become an offence

3. The laundering of illegally acquired property has been made an offence under the Act.

Removal of difficulties in the compliance of Section 50.

4. The provisions of Section 50 of the NDPS Act, non compliance of which has resulted in a large number of acquittals, have been made more flexible to cater to the real life situations where it is not practicable to take the person to be searched to the nearest Gazetted officer or Magistrate without the possibilities of the suspect parting with the drugs.

Controlled Delivery

5. Further to facilitate through and complete investigations and to neutralize the entire syndicate involved in drug trafficking, a provision has been made for the movement of seized drugs from one place to another place within and outside the country under controlled conditions.

Ambit of Sections 41 & 42 enlarged to include Controlled Substances and Financial Investigations.

 The provisions of search, seizure etc. under sections 41 & 42 shall now be applicable for cases relating to Financial Investigations and Controlled Substances also.

DRUG SITUATION IN INDIA

BORDERWISE TRENDS IN NARCOTICS SMUGGLING IN INDIA-2001

INDO-PAK BORDER

The Indo-Pak border has traditionally been most vulnerable to drug trafficking. During 2001, out of the total quantity of HEROIN seized in the country (889 kg.), about 184.517 kg.(21.0%) was sourced to South West Asia. The State wise break up of South West Asian origin Heroin seized during 2001, was Punjab 51.460 kg., Gujarat 40.008 kg., Delhi 39.863 kg., Rajasthan, 30.000 kg., J&K 15.000 kg., Maharashtra 7.000 kg., Haryana 3.000 kg. and Karnataka 0.850 kg.

The vulnerable areas of the border were Amritsar in Punjab, Jodhpur in Rajsthan, Akhnoor in J&K and Kheda in Gujarat. Analysis of the seizures effected during the year clearly indicate that Heroin originating in South West Asia managed to find its way to places as far remote from the Indo-Pak border as Tamil Nadu in deep Southern India.

INDO-MYANMAR BORDER

The Indian States of Arunachal Pradesh, Nagaland, Manipur and Mizoram have been vulnerable to the trafficking of heroin from Myanmar. Owing to their proximity to the Golden Triangle these States have been vulnerable to trafficking of high purity heroin flowing in small quantities.

In 2001, out of the total quantity of Heroin seized in the country (889) kgs.) 12.150 kg. (nearly 1.37 %) was seized in the North Eastern States of Assam (2.440 kg.), Manipur (3.580 kg.), Meghalaya (1.030 kg), Mizoram (3.670 kg.), Nagaland (0.030 Kg.) and Tripura (1.400 kg.)

Trafficking in these States is in much smaller quantities and therefore more difficult to detect. This is further accentuated by the existence of traditional cross-border

ethnic links, lack of restrictions in movement, inhospitable terrain and the problem of insurgency. Instances of drug abuse in these States are reported to be growing, including instances of intravenous intake, leading to the problem of spread of AIDS.

No significant departure from the trends noticed in earlier year was observed in the year 2001. Major portion of the South East Asian heroin meets the demand of local addict population and hardly ever gets transported to foreign destinations through India.

INDO-SRI LANKA SECTOR

Geographical proximity and ethnic links contribute to smuggling between coastal Southern India, especially the Southern Coromandel coast and Western coast of Sri Lanka by sea, mainly by small country crafts. As per information available, Colombo continued to serve as trans-shipment point for drugs transiting through India, bound for foreign destinations. During the year, drugs originating in South West Asia continued to find their way to the coastal areas of Kerala and Tamil Nadu for export via Sri Lanka to foreign destinations.

Tamil Nadu coast, especially Tuticorin and adjoining areas remained vulnerable from the point of view of drug trafficking mainly due to geographical proximity to Srilanka. A few seizures have also been reported from Chennai International Airport from the passengers leaving for Colombo. In 2001, 261.740 Kg. nearly (29.44%) of Heroin was seized in this sector.

COMMODITY WISE TRENDS DURING 2001

OPIUM :

During the year 2001, 2533 kg. of Opium was seized. Seizures have generally been around the poppy growing areas of Uttar Pradesh, Madhya Pradesh and Rajasthan. Almost the entire seizure is of domestic opium diverted from licit sources. There were no cases of opium smuggling into India.

MORPHINE :

Incidences of smuggling of morphine continued to be noticed in 2001. During 2001, 26 Kg. of Morphine was seized.

HEROIN :

In 2001, out of the total quantity of heroin seized in the country (889 kg.) about 187.181 kg. (21.05 %) was sourced from South-West Asia. Statements of the accused, place of seizure, markings on drug, routing etc. are taken into account while determining the origin of seized drug. Seizures without any such definite indications are not considered although they may have originated in SWA.

HASHISH :

During the year 2001, 5664 kg. of Hashish was seized in the country.

METHAQUALONE :

Recently a spurt in the seizure of Methaqualone has been noticed, which may be attributed to the stringent enforcement efforts of the law enforcement agencies. Current reports have also indicated major market for Methaqualone is in Southern Africa. During 2001, 2024 kg. of Methaqualone was seized in 8 cases.

ACETIC ANHYDRIDE :

Seizure trends clearly indicate strenuous efforts by the enforcement agencies in curtailing the smuggling of the chemical. During 2001, 8589 ltrs. of Acetic Anhydride was seized in 8 cases. In almost all cases, acetic anhydride was found to have been filtered in small quantities by tanker drivers and sold to illicit traffickers who accumulate this and supply to illicit drug manufacturers.

DRUG DEMAND REDUCTION IN INDIA

India with a population of over 1 billion has about 4 million (0.4 percent of total population) estimated drug addicts. They come from diverse socio- economic, cultural, religious and linguistic backgrounds.

The Government of India perceives addiction to drugs as a psycho-socio-medical problem, which can be best, handled through community- based interventions. Government of India is implementing a programme called the "Scheme for Prevention of Alcoholism and Substance (Drugs) Abuse " under which Non-Government Organisations are provided funds to generate awareness and sensitise the community, motivate the addicts for treatment and ensure their socio-economic rehabilitation through a long-term community based programme. Government is supporting about 450 centres all over the country with an average annual financial allocation of over Rs. 20 crores (approximately US \$ 4.5 million). These programmes are administered through the Ministry of Social Justice and Empowerment.

To strengthen the programme consistent with the commitment to the Guiding Principles on Demand Reduction, the Government has taken the following initiatives:

- To bring about standardisation and quality control in services and quality in services being delivered through the Non-Government Organisations, the Ministry has developed a Manual on Minimum Standards, which delineates the objectives of each activity under the Scheme, the minimum expected inputs and outputs, the responsibilities of each functionary, the physical environment of a centre and rights and duties of the staff and the clients.
- In order to redress the need to have a national policy document, the
 Government is in the process of developing a National Alcohol and Drug Demand

Reduction Strategy in consultation with all stakeholders, experts and international agencies.

- There are around 400 Non-Government Organisations funded by the Government in the field of alcoholism and drug abuse prevention. There are also around 100 de-addiction Centres in district hospitals, primary health centers etc funded by the Ministry of Health & Family Welfare. In addition, there are others who are working on their own. A directory of services incorporating all relevant facts is under preparation.
- The Government has developed a system/ protocol for collection, compilation and analysis of information from the implementation agencies for monitoring the trends, extent and pattern of drug abuse in the country so that the programmes and interventions could be effectively formulated.
- To further strengthen the community-based programme of the Government of, India, the United Nations International Drug Control Programme (UNDCP) and the International Labour Organisation (ILO) are collaborating with the Ministry of Social Justice & Empowerment, the nodal agency for demand reduction programmes, through the following project initiatives:
 - Community Wide Demand Reduction in India (AD/IND/99/E40 popularly known as E40)
 - Community Wide Demand Reduction in North-Eastern States of India (AD/IND/99/E41-popularly known as E 41)

The objectives of these projects is to strengthen NGO based intervention through establishing and capacitating a network of Centres of Drug Abuse Prevention (with a National centre at the apex for training, research and documentation), Regional Resource and Training Centres (vested in identified NGOs in different regions of the country, as the NGOs, Self-Help Groups at the city level to support rehabilitation of the addicts, and Workplace Prevention Programmes in different work settings through collaboration between NGOs and enterprises. The entire effort

is being supported through a massive programme of training of service providers and sensitisation of key functionaries, policy planners and legislators.

One of the major components of the Project is the establishment and operationalisation of the ARMADA or the Association of Resource Managers Against Drug Abuse- a network of representatives of enterprises, NGOs, Govts., experts, concerned citizens and all interested in order to propagte and strengthen the workplace prevention programme.

A project for the Northeast has been specifically designed keeping in mind the local customs, cultural traditions, community bonding as well as inadequacies in infrastructure in that region.

The Government has also undertaken a Project on National Survey on the trends, extent and pattern of drug abuse in the country in collaboration with the UNDCP. This survey, the first initiative of its kind in India shall provide an authentic profile of drug abuse in the country to facilitate appropriate policy formulation and programme interventions. The project has involved national as well as international expertise on epidemiology for this multi-approach survey. It has adopted three strategies viz. Household Survey, Rapid Assessment Survey and Drug Abuse Monitoring System in order to arrive at the best possible approximation of the drug scenario in the country. The survey has been completed and the final report is expected shortly.

SPREAD OF HIV/AIDS AMONGST SUBSTANCE ABUSERS

Around 3.5 million (0.35 % of total population) Indians were infected with HIV virus. Migration of labour, low literacy levels leading to low awareness, gender disparities, and prevalence of sexually transmitted diseases and reproductive tract infections are some of the factors attributed to the spread of HIV/AIDS.

There is a close co-relation between substance abuse and HIV/AIDS. While this is more direct and visible in the case of the injecting drug users (needle sharing), there is a greater, although subtler connection on account of substance abuse leading to deviant

behaviour, multiple sex partners, and loss of control leading to unsafe sex. It has been widely documented that there is a common at-risk and vulnerable group for both Substances Abuse and for HIV/AIDS. It is, therefore, necessary that NGOs engaged in Drug Demand Reduction are sensitized and develop skills for implementing activities related to HIV prevention.

The Ministry of Social Justice & Empowerment (MSJE) has been implementing the scheme for prevention of Alcoholism and Drug Abuse since 1986. The activities that are being funded through NGOs include De-addiction-cum-Rehabilitation Centres (DRCs) and Counselling Centres (CCs). Around 400 NGOs being so funded are running about 450 Centres.

Ministry of Social Justice and Empowerment (MSJE) and UNDCP have launched two projects in the recent past ie. E 40 – Community Wide Demand Reduction in India and E – 41 Community Wide Demand Reduction in Northeastern States of India. These two projects supplement the MSJE program supporting Non Government Organisations to carry out community linkages, human resources developed of service providers in these NGOs and advocate for greater private participation (through workplace prevention) focusing on harm minimization.

The HIV/AIDS prevention and management strategies of National AIDS Control Organization (NACO) and the State AIDS Control Societies are also implemented through NGOs. There are approximately 400 NGOs, which are presently being funded.

With the establishment of nexus between substance abuse and HIV/AIDS and commonality of target groups it is imperative that convergence and synergy needs to be established between the services for the categories under the control of the Ministry of Social Justice & Family Welfare.

The two Ministries have entered into a collaborative arrangement, wherein an additional worker has been attached to 100 NGO run Drug Deaddiction Centres, responsible for carrying out activities for HIV/AIDS Prevention. The additional activities for the

field worker include :

- Conduct Awareness Programmes on the basis of HIV/AIDS.
- Providing prevention counselling
- Conduct small group meetings
- Provide information of basic heath issues related to HIV/AIDS, STDs, sex and sexuality
- Mobilize resources like needles and condoms

Similarly prevention component on substance abuse prevention is being added to the HIV/AIDS treatment programme being implemented by the Ministry of Health.

TRAINING

- a) During 2001, the Bureau organised 19 in-house training courses, workshops, seminars etc. for enforcement officers from various enforcement agencies such as Customs, Central Excise, State Police, CBN, DRI etc. A total of 854 officers were participated in these training programmes/workshops/seminars.

c) The Bureau also provided faculty support to various training institutes in the drug laws training programmes. It has a Data Bank of resource persons consisting of retired and serving officers and experts in the field of drugs, who can cater to the needs of various training institutions. The list has been circulated to all training establishments across the country. The NCB has also brought out a training compendium and a compilation of judgements of Supreme Court of India in important NDPS cases in order to sensitize law enforcement officers on latest developments on interpretation of law and to improve the quality of investigation and prosecution.

SIGNIFICANT SEIZURES DURING 2001

GANJA 380.000 KG. PATNA

On 1.1.2001, Officers of Customs Commissionerate, Patna intercepted a truck loaded with raw jute near Kishanganj. Thorough search of the truck resulted in the recovery and seizure of 380 kgs. of contraband Ganja. Four persons were arrested in this connection.

HEROIN 17.900 KG. AMRITSAR

On 5.1.2001, acting on specific information officers of Directorate of Revenue Intelligence, Amritsar Regional Unit intercepted a truck at Naka point of Octroi post when the truck was coming to Jalandhar from Phagwara side. Search of the truck resulted in the recovery of 3 packets containing Heroin from a cabinet in driver's cabin and 15 packets containing Heroin from a LP Gas Cylinder lying in the tool box on the roof of the truck. The net weight of the recovered heroin was found to be 17.900 kg. The same was seized and driver of the truck was arrested. The suspected source of the seized drug was Pakistan.

HEROIN 24.060 KG. TIRUCHIRAPALLI

On 9.1.2001, Officers of Commissionerate of Customs, Tiruchirapalli seized 24.060 kg. of Heroin from two persons who were occupying a room in a lodge at Nagercoil, Tamilnadu. They were arrested. The suspected destination of the seized drug was Srilanka.

HEROIN 10.000 KG. TIRUCHIRAPALLI

On 9.1.2001, Officers of Commissionerate of Customs, Tiruchirapalli recovered and seized 10.000 kg. of Heroin from a place at Kootapalli Seashore near Kanyakumari, Tamilnadu. The suspected destination of the seized drug was Srilanka.

HASHISH 110.000 KG. PATNA

On 11.1.2001, Officers of Customs Commissionerate, Patna based on secret information intercepted one ambassador car near Valmiknagar. Search of the car resulted in the recovery and seizure of 110.000 kg. of Hashish which was secreted in a specially made cavity in the said vehicle. Two persons were arrested in this connection. The suspected source of the seized drug was Nepal.

ACETIC ANHYDRIDE 1390.000 LTS. MUMBAI

On 15.1.2001, Officers of Narcotics Control Bureau, Mumbai Zonal Unit based on specific intelligence intercepted one Haren I Sanghavi while he was in the process of taking delivery of a consignment of 1390 lts. of Acetic Anhydride from the Godown of M/s Vijay Transport Co. Ltd., Village Purna, Tal. Bhiwandi, Distt. Thane. The afore- mentioned consignment of Acetic Anhydride was seized under NDPS Act.

ACETIC ANHYDRIDE 7050,000 LTS. AHMEDABAD

On 17.1.2001, Officers of Narcotics Control Bureau, Ahmedabad Zonal Unit based on specific intelligence received from Mumbai Zonal Unit about illegal storage of Acetic Anhydride in a godown in Madhav Ware House at N.H.8 Aslali, Ahmedabad, the premises was researched which resulted in the recover and seizure of 7050 kg. of Acetic Anhydride.

EPHEDRINE 792.000 KG. ASSAM

On 17.1.2001, Officers of Assam Police, Khatkhati O.P. Dist. Karbi Anglong, Assam intercepted a truck. Search of the drug resulted in the recovery and seizure of 792.000 kg. of ephedrine which was concealed under other articles inside the truck. Three persons were arrested in this connection.

GANJA 103.000 KG. MADHYA PRADESH

On 23.1.2001, Officers of Madhya Pradesh Police seized 103.000 kg. of Ganja at Madanmahal Distt. Jabalpur and arrested two persons in this connection.

HEROIN 15.000 KG. JODHPUR

On 25.1.2001, Based on specific information officers of 'G' Branch of BSF Jodhpur carried out search operation near BOP Navapura. They observed suspicious movements about five hundred yards of border fencing. When the party advanced toward the spot the suspect place his back load into the bushes and ran away. On search of the area a plastic bag of blue colour was found inside the bushes. The bag was opened and found to contain 15 packets of Heroin weighing each packet 1 kg. A total of 15.000 kg.of Heroin was seized as unclaimed. The suspected source of the drug was Pakistan.

HEROIN 2.000 KG. MUMBAI

On 3.2.2001, based on specific information officers of Narcotics Control Bureau, Mumbai Zonal Unit searched the residential premises of a person situated at First Floor, Bhimaji Bhuva Compound, Mahananda Nagar New Mill Road, Kurla, Mumbai. The search was resulted in the recovery and seizure of 2.000 kg. of Brown powder purported to be Heroin. Two persons were arrested in this connection.

HEROIN 5.000 KG. MANGALORE

On 7.2.2001, the officers of Directorate of Revenue Intelligence, Mangalore seized 5.000 kgs. of Heroin from a person at Surath Kal, Karanataka and arrested him.

HEROIN 16.060 KG. AMRITSAR

On 8.2.2001, acting of specific information officers of DRI, Amritsar intercepted a truck near Satish & Company Petrol Pump G.T.Road, Pathankot. Search of the truck

resulted in the recovery of 16.060 kg. of white granual type powder purpoted to be heroin which was concealed in the spare tyre of the truck. The driver of the vehicle was arrested. The suspected source of the drug was Pakistan.

On 8.2.2001, based on specific information officers of Narcotics Control Bureau, Mumbai Zonal Unit searched a tata truck at the premises of M/s High Point Industries, MIDC Taloja which was resulted the recovery and seizure of 1423.690 kgs. of Mandrax tablets. Three persons were arrested in this connection.

On 10.2.2001, the officers of Assam Police Guwahati opened the bank locker no.12 of Canara Bank which was in the name of one of the accused and recovered and seized 0.249 kg. of Heroin. The contraband drug was packed in white colour polythene packets marked as "DOUBLE UOGLOBE Brand, 100%. The suspected source of the drug was Myanmar. A Indica Car suspected to be used for drug trafficking was also seized. Four persons were arrested in this connection.

One person was arrested in this connection.

20.400 kg. of Mandrax Tablets. The tablets were cleverly concealed in round holes running through the cross sections of wooden stump which were the inner frame work of the flush doors. The destination of the Mandrax was Port Elizabeth, South Africa and the consignee was M/s Khilji Collections CC, 33 West Street, 4-Master Mansion, Johannesburg, South Africa.

HEROIN 2.500 KG. DELHI

On 19.3.2001, the officers of Delhi Police laid a trap near Tikona Park near Dargah, West Nizamuddin at about 6 P.M. where two persons had appeared with black coloured suitcases. They were apprehended and on opening the suitcases it was found that two packets were concealed in the bottom cavity of the suitcases. The same was opened and found to be containing 2.500 kg. each of Heroin. The same was seized and both the accused were arrested. One of the accused was a Bangladeshi national. The suspected source of the drug was Pakistan.

As a result of rummaging of the vehicles, 17.000 kg. of Heroin were recovered and seized. Two persons were arrested in this connection. The suspected source of the drug was South West Asia.

On 26.4.2001, the officers of Mumbai Zonal Unit of Narcotics Control Bureau

examined a consignment of one cardboard box destined to Johannesburg by South African Airways. The said consignment was neither authorised/nor manifested. The name of the consignor was also not specified. On examination it was found to have containing 27 packets weighing 21.800 kg. of white coloured substance suspected to be Methqualone. The same was seized as unclaimed.

On 4.1.2002, the officers of Narcotics Control Bureau, Delhi Zonal Unit intercepted a maruti car near Nehru Park, New Delhi. The search of the vehicle resulted in the recovery of 7.000 kg. of Heroin packed in raxine bag and concealed under the front seat of the car. The drug was seized and one person was arrested. In the follow up action, search of a residence at Safdarjung Enclave led to the recovery and seizure of 0.100 kg.of Heroin and arrest of another person. HASHISH 86.700 KG. AHMEDABAD

The suspected source of the drug was Pakistan.

DIAZEPAM 5000 TABLETS UTTAR PRADESH

On 19.3.2002, the officers of Uttar Pradesh Police seized 5000 tablets of Diazepam from a person at Jaitpur, Varanasi and he was arrested.

DIAZEPAM 1000 TABLETS UTTAR PRADESH

On 22.3.2002, the officers of Uttar Pradesh Police seized 1000 tablets of Diazepam from a person at Jaitpur, Varanasi and he was arrested.

HEROIN 0.525 KG. TRIVANDRUM

HASHISH OIL 1.045 KG

On 23.3.2002, the officers of Narcotics Control Bureau, Trivandrum Regional Intelligence Unit apprehended a person opposite Srikumar threatre, Thampanoor, Trivandrum and seized 1.045 kg. of Hashish Oil and 0.525 kg. of white powder suspected to be psychotropic substances. The drug was packed in polythene packets concealed in a yellow polythene bag with markings CENTER FRESH and kept in a white polythene bag. He was arrested.

CHARAS 40.000 KG. PATNA

On 25.3.2002, the officers of Customs, Patna seized 40.000 kg. of Charas from an ambassdor car parked near Hardeya Kothi on Raxaul-Motihari Road. The car was also seized. The suspected source of the drug was Nepal.

CHARAS 29.500 KG. VARANASI

On 26.3.2002, the officers of Narcotics Control Bureau, Varanasi Zonal Unit and Directorate of Revenue Intelligence, Muzaffarpur seized 29.500 kg. of Charas from Kanti Railway Station, Bihar. The drug was concealed inside the side wall of toilet in a Bogie of 528 Dn. Passenger train standing at the station. The drug was unclaimed.

On 29.3.2002, the officers of Maharashtra Police apprehended two persons near Milan Lodge at Pune Station and seized 0.470 kg. of Cocaine and 0.485kg. of Heron from their possession. Both the accused were arrested.

SIGNIFICANT SEIZURES OF HEROIN OF SWA ORIGIN

On 3.1.2001, Officers of Commissionerate of Customs, Mall Road, Amritsar and Border Security Force in a joint operation recovered 2.5 kg. of Heroin which was buried under the soil near BOP Daoke on the other side of the fencing. The same was seized as unclaimed. The suspected source of the seized drug was Pakistan.

On 5.1.2001, acting on specific information officers of Directorate of Revenue Intelligence, Amritsar Regional Unit intercepted a truck at Naka point of Octroi post when the truck was coming to Jalandhar from Phagwara side. Search of the truck resulted in the recovery of 3 packets containing Heroin from a cabinet in driver's cabin and 15 packets containing Heroin from a LP Gas Cylinder lying in the tool box on the roof of the truck. The net weight of the recovered heroin was found to be 17.900 kg. The same was seized and driver of the truck was arrested. The suspected source of the seized drug was Pakistan.

On 25.1.2001, Based on specific information officers of 'G' Branch of BSF Jodhpur carried out search operation near BOP Navapura. They observed suspicious movements about five hundred yards of border fencing. When the party advanced toward the spot the suspect place his back load into the bushes and ran away. On search of the area a plastic bag of blue colour was found inside the bushes. The bag was opened and found to contain 15 packets of Heroin weighing each packet 1 kg. A total of 15.000 kg.of Heroin was seized as unclaimed. The suspected source of the drug was Pakistan.

On 8.2.2001, acting of specific information officers of DRI, Amritsar intercepted a truck near Satish & Company Petrol Pump G.T.Road, Pathankot. Search of the truck resulted in the recovery of 16.060 kg. of white granual type powder purpoted to be heroin which was concealed in the spare tyre of the truck. The

driver of the vehicle was arrested. The suspected source of the drug was Pakistan.

On 26.2.2001, Officers of Narcotics Control Bureau, Jammu Zonal Unit, based on information from Border Security Force posted near B.P.No. 1034 seized 15.000 kg. of Heroin which was concealed in 15 packets as unclaimed. The suspected source of the drug was Pakistan.

On 19.3.2001, the officers of Delhi Police laid a trap near Tikona Park near Dargah, West Nizamuddin at about 6 P.M. where two persons had appeared with black coloured suitcases. They were apprehended and on opening the suitcases it was found that two packets were concealed in the bottom cavity of the suitcases. The same was opened and found to be containing 2.500 kg. each of Heroin. The same was seized and both the accused were arrested. One of the accused was a Bangladeshi national. The suspected source of the drug was Pakistan.

On 5.4.2001, the officers of the Border Security Force, Rohidi Post shot down a person at Rohidi Forward (on Indo-Pak Border) while trying to intrude into India through border fencing near border pillar no. 806-1/S. The deceased was carrying a white plastic bag tied on his shoulders. After arrival of the local police, dead body and its belonging were searched which resulted in the recovery of 10.000 kg. of Heroin alongwith Rs.510/- (Pakistani currency) and Rs.1000/- (Indian currency). The contraband heroin and currency were handed over to Customs. The suspected source of the drug was Pakistan.

On 17.4.2001, the officers of Directorate of Revenue Intelligence, New Delhi intercepted two vehicles at National High Way No.8 opposite Shiva Temple, Delhi Gurgaon Road while the occupants of the vehicles were transferring a bag containing narcotic drugs from one vehicle to another. As a result of rummaging of the vehicles, 17.000 kg. of Heroin were recovered and seized. Two persons were arrested in this connection. The suspected source of the drug was South West Asia.

On 30.4.2001, based a specific information the officers of Delhi Zonal Unit of Narcotics Control Bureau intercepted a lady near Ashok nagar Railway crossing Delhi. Search of the polythene bag she was carrying resulted in the recovery and seizure of 1.000 kg. of Heroin. Subsequent search of her residence at A-186, Amit Vihar, Behta Hazipur, Ghazibad resulted in the seizure of 2.000 kg. of Heroin and Rs.49,000/-. Three persons were arrested in this connection.

On 25.5.2001, the officers of Haryana Police intercepted an auto and search of the vehicle resulted in the recovery and seizure of 3.000 kg. of Heroin, which was in the possession of a Nigerian national. The Nigerian and his other accomplice managed to escape.

On 6.7.2001, based on specific information a joint enforcement operation was carried out by the officers of Narcotics Control Bureau, Jodhpur Zonal Unit and Border Security Force, Barmer, which resulted in the seizure of 5.000 kg. of Heroin from a place near border (Jharapa). The suspected source of the drug was Pakistan.

On 10.7.2001, based on specific information the officers of Gujarat Police intercepted a truck at L&T Tax Toll Naka Radhwanaj. Search of the vehicle resulted in the recovery and seizure of 35 bags of heroin weighing 33.894 kg. One person was arrested in this connection. The suspected source of the drug was Pakistan.

On 6.8.2001, based on specific information, the officers of Directorate of Revenue Intelligence, Bangalore searched the Pharmaceuticals factory premises at Maniar Complex, Koppikar Road, Hubli, Bangloare. But no narcotic substances for incriminating documents were found. While coming out of the premises a person carrying four plastic bags was noticed. Of the four three packets had marking of YY in blue color and 999 on it. Search of the four packets resulted in the recovery and seizure of 2.300 kg. of Opium and 0.850 kg. of Heroin. The person was arrested. The suspected source of the drug was SWA.

On 22.8.2001, the officers of Narcotics Control Bureau, Mumbai Zonal Unit based on specific information had recovered drugs. 527 heroin capsules weighing 7.000 kg. which were concealed inside the bodies of eleven African nationals who had arrived from Karachi, Pakistan.

On 31.8.2001, the officers of Directorate of Revenue Intelligence, New Delhi intercepted a car near milk booth, Hanuman Mandir, Baba Kharag Marg, New Delhi. The search of the vehicle resulted in the recovery and seizure of 5.797 kg. of Heroin. One person was arrested. The suspected source of the drug was South West Asia.

On 5.10.2001, the officers of Directorate of Revenue Intelligence, New Delhi intercepted a car at New Delhi. The search of the vehicle resulted in the recovery and seizure of 9.066 kg. of heroin, concealed in the panel of left front door of the Car. Three persons were arrested in this connection.

On 25.10.2001, the officers of Directorate of Revenue Intelligence, Amritsar intercepted a maruti car at Container Freight Station (OWPL) Ludhiana, Punjab. The search of the vehicle resulted in the recovery and seizure of 15.000 kg. of Heroin. The drug was concealed in the door panels of the car. Two persons were arrested in this connection. The suspected source of the drug was Pakistan.

On 9.11.2001, the officers of Narcotics Control Bureau, Ahmedabad Zonal Unit apprehended three persons at Panetar Palace Guest House and seized 2.000 kg. of Heroin from them. All the accused were arrested.

On 20.1.2002, the officers of Rajasthan Police apprehended a person at Bhabhuri Ki Thani, Beezrand, Distt. Barmer and seized 27.300 kg. of Heroin from him. He was arrested. The suspected source of the drug was Pakistan.

SEIZURES OF ACETIC ANHYDRIDE EFFECTED DURING 2001

On 15.1.2001, Officers of Narcotics Control Bureau, Mumbai Zonal Unit based on specific intelligence intercepted one Haren I Sanghavi while he was in the process of takiing delivery of a consignment of 1390 kg. of Acetic Anhydride from the Godown of M/s Vijay Transport Co. Ltd., Village Purna, Ial. Bhiwandi, Distt. Thane. The afore- mentioned consignment of Acetic Anhydride was seized under NDPS Act.

On 17.1.2001, Officers of Narcotics Control Bureau, Ahmedabad Zonal Unit based on specific intelligence received from Mumbai Zonal Unit about illegal storage of Acetic Anhydride in a godown in Madhav Ware House at N.H.8 Aslali, Ahmedabad, the premises was researched which resulted in the recover and seizure of 7050 kg. of Acetic Anhydride.

On 24.3.2001, Officers of Central Bureau of Narcotics, Rajasthan Unit searched the residential premises and farm house of a person at Salamgarh, Chittorgarh, which resulted in the recovery and seizure of 14.000 ltrs. of Acetic Anhydride, 0.420 kg. of Ganja, Indian currency amounting to Rs.3,91,000/-, two Tata trucks, a Mahindra jeep and one Rajdoot Motor Cycle. Two guns have also been recovered from the residence of the suspect but he could not be arrested as he was not present at the time of the search.

On 26.2.2001, Officers of Central Bureau of Narcotics, Rajasthan Unit searched the residential premises of a person at Dhaker Khedi, Kota which was resulted in the recovery and seizure of 1.750 Ltrs, of Acetic Anhydride along with one local made revolver. He was arrested.

On 2/7.5.2001, the officers of Central Bureau of Narcotics, Kota Rajasthan seized 0.450 kg. of heroin from a room at Welcome Guest House in front of Pareek College, Jaipur and arrested three persons. In a follow up action—an illicit

drug manufacturing laboratory was busted and 1.000 ltr. of Acetic Anhydride, 1.000 ltr. liquid opium, 0.350 ammonia, 0.500 kg. of opium, 1,400 of Paracetamol tablets, balance weighing machine two motor cycles and one car were also seized. Four more persons were also arrested.
