NCB achieves 17 convictions in 15 days

On account of its emphasis on professional conduct of trial of NDPS cases the Narcotics Control Bureau has in last 15 days achieved conviction of 17 accused in 06 matters, relating to the recoveries made in the state of Assam, UP, Punjab, Jharkhand, Kerala and Tamil Naidu.

1. In the first case.

The court of Additional District & Sessions Court, Kamrup on 01.04.2025 convicted 02 accused arrested with 600 Kgs of Ganja by NCB on 20.01.2021. This consignment was concealed in a secret chamber inside a truck was being smuggled from Tripura to Uttar Pradesh. The convicted accused were sentenced to 10 years of rigorous imprisonment and fine of Rs. 1 lakh each.

2. In second matter.

The court of Additional District Judge, Lucknow convicted an accused on 01.04.2025 arrested by NCB on 20.05.2019 with 500 grams of Alprazolam. He has been sentenced to 10 years of rigorous imprisonment and fine of Rs. 1 lakh.

3. In third instance.

The Special NDPS court in Mohali on 24.03.2025 convicted four accused arrested by NCB on 20.09.2021. The arrest of these drug smugglers had led to recovery of 21.370 Kgs of charas sourced from Himachal Pradesh. The court sentenced 03 accused to 15 years of rigorous imprisonment and a fine of Rs.1.5 lakh each, One other accused was sentenced to 10 years of rigorous imprisonment and a fine of Rs.1 lakh

4. In fourth case.

The court of Hon'ble special NDPS court Jamshedpur convicted five accused on 24.03.2025 arrested by NCB on 25.11.2021 with 425.5 Kgs of Ganja sourced from Odisha. The convicted accused were sentenced to 20 years of rigorous imprisonment and a fine of Rs.2 lakh each.

5. In fifth instance.

The court of Hon'ble NDPS Act at Manjeri, Malappuram, Kerala, convicted two accused on 05.04.2025, they were arrested by NCB on

04.09.2023 with 46 LSD blots, 33.909 grams of Hashish, 5.340 grams of Methamphetamine, and 21.88 grams of Hashish oil (3 cartridges). The convicted accused have been sentenced to 12 years of rigorous imprisonment and fine of Rs.1 lakh each.

6. In sixth matter.

The court of Hon'ble NDPS Court, Madurai convicted three accused on 05.04.2025, these accused were arrested by NCB on 02.02.2021 with 26.09 Kgs of hashish oil. The convicted accused were sentenced to 12 years of rigorous imprisonment and a fine of Rs.1 lakh each.

These convictions exemplify the NCB's commitment to successfully dismantling drug networks to accomplish the vision of DRUG FREE INDIA.
