### **NOTICE FOR APPLICATION**

Applications are invited for appointment of advocates as Senior Public Prosecutor to represent the Office of DDG, Southern Region, NCB, Chennai and Chennai Zonal Unit, NCB Chennai on contract basis.

#### **Details of eligibility criteria and other terms and conditions**

##### **1. Eligibility Criteria**

a)	<b>Senior Public Prosecutor (Sr. PP)</b>	Advocates with experience of ten years or more at the Bar.

##### **2. Nature of Duties:**

The candidates appointed as Senior Public Prosecutor shall be required to assist to the Office of DDG, Southern Region, NCB, Chennai and Chennai Zonal Unit, NCB Chennai, separately for providing legal advice on investigation when the enquiry/investigation is underway, guide to improve the quality of evidence to be gathered during investigation, develop expertise in presenting the case for prosecution, monitor the progress of trial, submit court diaries and perform such other duties of legal nature, which may be assigned by the NCB.

### **3. Place of Work, Vacancies and emoluments:**

- I. A total of 02 vacancies for Senior PP are available. 01 at Office of DDG, Southern Region, NCB, Chennai and 01 at Chennai Zonal Unit, NCB Chennai.
- II. The Senior Public Prosecutor (SPP) will draw a payment of Rs. 100000/- (One Lac) per month (consolidated). No additional allowances viz HRA, Medical, LTC, except TA/DA as per entitlement shall be paid.

### **4. Terms and Conditions:**

- I. The tenure for appointment of Sr.PP shall be for 03 years or till appointment of regular Sr. PP, whichever is earlier.
- II. The Sr. PP on having accepted the offer of appointment, shall enter into a Contract, having the confidentiality clause, integrity clause and non-compete clause with the Narcotics Control Bureau.
- III. Any breach of Contract by the Sr.PP with the NCB shall be considered a sufficient ground for termination of contract.
- IV. The Sr.PP shall not be allowed to engage in private practice.
- V. Notwithstanding anything contained herein above, the NCB and/or the Counsel may terminate the appointment with one month's advance notice.
- VI. Sr.PP with immediate effect will hand over the charge/records to the successor on the expiry/ termination of the contract.

### **5 Selection Process**

Only shortlisted candidates will be called for further selection process individually. Intimation in this regard shall be sent on their registered email id, and through telephone. No TA/DA will be paid to candidates for appearing at the interaction. On completion of selection process, information shall be sent to the selected candidates through e-mail and telephone.
