**Subject: - Filling up of three posts of Superintendent (Cyber) (Level-8) in the Narcotics Control Bureau, Ministry of Home Affairs on deputation including short term contract (STC) basis.**

Narcotics Control Bureau, Ministry of Home Affairs intends to fill up 03 **(three) posts** of Superintendent (Cyber) on deputation including Short Term Contract (STC) basis at **NCB Hqrs., New Delhi.**

2. The post of Superintendent (Cyber) carries the pay scale in Level-8 (Rs. 47,600-1,51,100) as per 7<sup>th</sup> CPC Pay Matrix (PB-2 Rs.9300-34800 + Grade Pay of Rs.4800, pre-revised).
3. The method of recruitment is 100% by deputation including Short Term Contract.
4. The terms and conditions of the deputation will be governed by the Department of Personnel & Training's OM No. 6/8/2009-Estt. (Pay II) dated 17.06.2010, as amended from time to time.
5. Officers under the Central Government or State Governments or Union Territories or Autonomous or Statutory Organization or Public Sector Undertaking or recognized universities are eligible to apply for deputation including Short Term Contract.

**Eligibility criteria for deputation including Short Term Contract-**

- a)
  - i) Holding analogous posts on regular basis in the parent cadre or department; **or**
  - ii) With two years' service in the grade rendered after appointment thereto on a regular basis in posts in the level-7 of pay matrix or equivalent; **or**
  - iii) With six years' service in the grade rendered after appointment thereto on a regular basis in posts in the level-6 of the pay matrix or equivalent and
- b) Possessing the educational qualifications and experience: -

- i) Master's Degree in Cyber Security Forensics/Digital Forensics, or Masters Degree in Computer Application or Computer Science or Master of Technology (with specialization in Computer Application); or B.E./B.Tech in Computer Engineering/Computer Science/Computer Technology/ Computer Science Engineering/ Information Technology/

Computer Application/ Electronics or Electronics and Communication Engineering from a recognized University/Institute and

- ii) Two years' experience of digital foot printing and digital forensic: -

**Digital foot printing:** knowledge/experience of CDR, IPDR analysis, web crawling and indexing, skills at on python, social engineering and reverse engineering.

**Digital Forensic:** Knowledge /experience of using write blocker, imaging, utilization and extraction of deleted data, Network forensics, Data Recovery Techniques, Digital evidence handling procedure.

**Desirable:-**

Certificate course in Comp TIA (The Computing Technology Industry Association / Dark web / Blockchain/ Social Media Monitoring/ Crypto Analysis.

**Standard Note:**

The period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/ department of the Central Government shall ordinarily not to exceed **three years**. The Maximum age limit for appointment by deputation shall be not exceeding fifty-six years as on the last date of receipt of applications.

**6. This is an open vacancy circular, meaning that applications will be considered on a continuous basis until all vacancies are filled. The complete applications received by last day of every month shall be considered for selection against available vacancies at the end of said month.**

- iv) Vigilance Clearance certificate as per proforma
- v) Major/minor penalty statement for the last 10 years and
- vi) Cadre clearance incorporating that in the event of his/her selection, he/she will be relieved to join the post of Superintendent (Cyber) in NCB on deputation including Short Term Contract (STC) basis.
